This first translation of the Liber Augustalis from the Latin into a modern language makes available to a wide audience one of the most important sources for medieval legal and social history. The victorious Emperor Frederick II ordered the compilation of this body of law as a cornerstone of his royal authority. Blending many disparate influences and legal traditions into a common law, the Liber Augustalis reveals much of thirteenth century political and social life, the conception of the monarchy and its rights and responsibilities, and the manner in which thirteenth-century lawyers attempted to deal with the problems of their day.

The Constitutions are divided into three Books, Book I is concerned with public law, questions of heresy, the basis of royal power, and the officials of the kingdom. Book II is devoted chiefly to procedural law in both civil and criminal cases, and Book III deals with feudal and private law and the punishment of crimes. Anyone reading this volume will be struck by how far-sighted many of these laws were, and how fresh they seem even to twentieth-century eyes-laws dealing, for instance, with the legal status of women, adultery, prostitution, courtroom conduct, mal-

practice, and even air pollution.

The importance of this book to the legal scholar and the medievalist is apparent. The nonspecialist will find that the unusual clarity and directness of the translation makes it wholly accessible-and fascinating-to him as well.
