In our article, "Biological Relationships between Foragers and Farmers of South-central North America: Nonmetric Dental Traits" (*American Antiquity*, Vol.77, No. 1, p. 103), we stated that "No remains were examined without prior approval of the project from the appropriate tribal officials or state/federal governmental agency." We wish to clarify that the collections that are curated at Southern Methodist University, at the University of Texas at El Paso, and at New Mexico State University were not included in our study because we did not have approval from the relevant tribal officials of the culturally affiliated Native American tribe(s) for research on these particular collections. The position of the tribal officials does not reflect the position of any of these three curating institutions regarding the research. We would like to note again our appreciation of the cooperation of so many tribes, universities, and museums in this effort.
