Faiz Ahmed Faiz (1911–1984), by the British act of partition a Pakistani, was the most important contemporary poet of India and the subcontinent. Throughout that vast region everyone who knows any poetry at all knows of Faiz. When he read at a *mushai'rai*, or poetry recitation, fifty thousand people and more were known to gather to listen and participate.

Naomi Lazard worked closely with him on this translation from the Urdu in the years immediately before his death. In this bilingual edition of Faiz's mature work, she captures his universal appeal: a voice of great pathos, charm, and authenticity that has until now been little known in the English-speaking world.

PMLA (ISSN 0030-8129) is issued six times a year, in January, March, May, September, October, and November, by the Modern Language Association of America. Membership is open to those persons who are professionally interested in the modern languages and literatures. Annual dues, which include subscription to PMLA, are based on members' salaries and are graduated as follows: student members (four years maximum), \$10; new regular members (first year), \$25; regular members (salary under \$12,000), \$10; regular members (salary \$12,000–\$15,000), \$35; regular members (salary \$15,000-\$20,000), \$45; regular members (salary \$20,000-\$25,000), \$50; regular members (salary \$25,000-\$30,000), \$55; regular members (salary \$30,000-\$35,000), \$60; regular members (salary \$35,000-\$40,000), \$65; regular members (salary \$40,000-\$45,000), \$70; regular members (salary \$45,000-\$50,000), \$75; regular members (salary \$50,000-\$55,000), (salary \$65,000-\$70,000), \$95; regular members (salary \$70,000-\$75,000), \$100; regular members (salary \$75,000 and above), \$105; joint members (two individuals sharing the same household, who receive one subscription to PMLA but two copies of all other publications), add \$20 to dues category of higher-income member; foreign members, same as regular members (ascertain dues category based on American dollar equivalent). Membership applications are available on request.

The subscription price of PMLA for libraries and other institutions is \$80. A subscription including a bound volume at the end of the year is \$195, domestic and foreign. Agents deduct 4% as their fee. Single copies of the January, March, May, and October issues may be obtained for \$7.50 each; the November (Program) issue for \$20; the September (Directory) issue for \$35.

#### Manic-Depressive Psychosis and Critical Approaches to Virginia Woolf's Life and Work. THOMAS C. CARAMAGNO . . . 10

**Abstract.** Although recent scientific discoveries about the genetic and biochemical components of manic-depressive psychosis have radically revised our understanding of the etiology and psychodynamics of this illness, psychological studies of Virginia Woolf's life and work have generally remained tied to Freud's outmoded model of loss-induced neurosis. This model appeals to critics because it readily imposes coherence on often inconsistent biographical data, but it fails to account for psychotic breakdowns and tends to disparage Woolf with its emphasis on the infantile and evasive aspects of art. Since Woolf's symptoms do fulfill the manic-depressive paradigm, a consideration of how contemporary psychiatric theory alters our reading of her life may also explain the therapeutic value of her bold experiments in fiction as well as her profound insights into subject-object transactions and the pitfalls of interpretation in general. #### "If I Saw You Would You Kiss Me?": Sapphism and the Subversiveness of Virginia Woolf's Orlando. SHERRON E. KNOPP

Abstract. Woolf called *Orlando* a "joke," an "escapade," and critics have taken her at her word. Although an enormous amount has been written about Woolf, the novel that celebrates her love for Vita Sackville-West tends to be ignored, dismissed as an anomaly, or explained as something other than what it is. But the things we joke about are often the things we care about too much to risk seriousness. The bold and dazzling achievement of Woolf's "joke" only becomes clear when *Orlando* is set in the context of the love that inspired it and seen against the social, historical, and literary background in which it was conceived. #### "Put God in Your Debt": Emerson's Economy of Expenditure. RICHARD A. GRUSIN

Abstract. Emerson's economic thought has most often been interpreted from the perspective of a Marxist analysis of trade and production. Such a perspective fails to distinguish between the different levels of Emerson's thinking—spiritual, commercial, and natural. Following the logic of symbolic exchange employed as a critique of Marxism by Mauss, Bataille, Baudrillard, and others, this essay argues that Emerson's economy of expenditure not only contradicts the basic premises of Marxist doctrine but also alters our understanding of such fundamental Emersonian concepts as self-reliance and compensation. # "Say First What Cause": Ricoeur and the Etiology of Evil in *Paradise Lost*. JOHN S. TANNER

Abstract. Paradise Lost traces evil through three inceptions—Satanic, Adamic, and historical. Each origin seems to envision a different etiology: Satanic evil springs exclusively from the self in an instant of radical "Pelagian" freedom. Adamic evil emerges from the ambiguous interplay between self and seductive environment. Historical evil contaminates the whole race by means of necessary "Augustinian" inheritance. Ricoeur's analysis of the "Adamic Myth" and original sin clarifies etiological traditions Milton assimilates from Christian symbol, myth, and dogma. Through Ricoeur, we can identify the contrasting modalities of evil (inherited and imitative, physical and moral, ontological and existential, necessary and free, communal and individual) fused in *Paradise Lost*. Ricoeur's work reveals Milton's text to be a subtly inclusive etiological myth, one whose complex genesis of evil recovers Scripture's fullness of meaning in a new mythopoesis. (JST)

#### A STATEMENT OF EDITORIAL POLICY

PMLA welcomes essays of interest to those concerned with the study of language and literature. As the publication of a large and heterogeneous association, the journal is receptive to a variety of topics, whether general or specific, and to all scholarly methods and theoretical perspectives. The ideal PMLA essay exemplifies the best of its kind, whatever the kind; addresses a significant problem; draws out clearly the implications of its findings; and engages the attention of its audience through a concise, readable presentation. Articles of fewer than 2,500 words or more than 9,000 words are not considered for publication. The word count includes notes but excludes translations, which should accompany foreign language quotations. The MLA urges its contributors to be sensitive to the social implications of language and to seek wording free of discriminatory overtones.

Only members of the association may submit articles to PMLA. Each article submitted is sent to at least one consultant reader and one member of the Advisory Committee. Articles recommended by these readers are then sent to the members of the Editorial Board, who meet periodically with the editor to make final decisions. Until a final decision is reached, the author's name is not made known to consultant readers, to members of the Advisory Committee and the Editorial Board, or to the editor.

Submissions, prepared according to The MLA Style Manual, should be addressed to the Editor of PMLA, 10 Astor Place, New York, NY 10003-6981. An author's name should not appear on the manuscript; instead, a cover sheet, with the author's name, address, and the title of the article, should accompany the article. Authors should not refer to themselves in the first person in the submitted text or notes if such references would identify them; any necessary references to the author's previous work, for example, should be in the third person.
