INSTITUTE NOTES

OBJECTS OF THE INSTITUTE

The aims of the Royal Institute of Philosophy are to promote the study of philosophy and to encourage original work in it. The main ways in which the Institute pursues these aims are by organising programmes of lectures, by publishing a quarterly journal, by running an annual book competition, and by holding conferences. The lectures given at the Institute's headquarters, 14 Gordon Square, London W.C.1, are published in the January following the lecture session, as a volume in the ROYAL INSTITUTE OF PHILOSOPHY LECTURES series. In the Institute's quarterly journal, Philosophy, philosophical problems are discussed, and new books reviewed, by writers whose care it is to make themselves understood by the public at large as well as by their professional colleagues. The term 'philosophy' covers a wide group of studies, which have been differently pursued at different times. The Royal Institute of Philosophy interprets 'philosophy' as covering ethics, aesthetics, metaphysics, epistemology, logic, philosphy of science, political and social philosophy, philosophy of history, philosophy of education and the philosophies of mind and language. The Institute is not committed to any school or method, but seeks to provide a forum for the rational discussion of questions in all these fields.

The Institute welcomes as members all those who are interested in philosophical problems, irrespective of their professional qualifications.

The annual subscription to the Institute is £2 10s (\$6.50 in the U.S.A. and Canada). Members receive the Institute's journal Philosophy, published quarterly, and may of course attend the lectures. The membership subscription does not cover the cost of volumes in the ROYAL INSTITUTE OF PHILOSOPHY LECTURES series, which are published by Macmillan & Co., in London, and by St. Martin's Press in New York, and are obtainable from bookshops.

There are centres of the Institute at the University of Newcastle-upon-Tyne and the University College of North Wales, Bangor.
