**Brian Conway** is lecturer in sociology at Maynooth University, Ireland. Previously, he was lecturer in the School of Applied Social Studies at Robert Gordon University, Scotland. His main research interest is the sociology of religion, especially Catholicism, and his recent work appears in the *International Journal of Comparative Sociology*, *Review of Religious Research*, *Sociological Perspectives*, and *The American Sociologist*. He is editor of the *Irish Journal of Sociology*.

**Ileen A. DeVault** teaches in the Department of Labor Relations, Law, and History at the ILR School at Cornell University. She has written two books, *Sons and Daughters of Labor: Class and Clerical Work in Turn-of-the-Century Pittsburgh* (1990) and *United Apart: Gender and the Rise of Craft Unionism* (2004) and articles, including “Family Wages: The Roles of Wives and Mothers in Working-Class Survival Strategies, 1880–1930” in *Labor History* (2013). She is currently researching the impact of men’s family status on their workplace experiences. She is Co-Chair of the Equity at Work Initiative of the Worker Institute at Cornell.

**Benoit Dostie** is a full professor at the Department of Applied Economics of HEC Montréal, the business school affiliated with l’Université de Montréal, where he holds the HEC Montréal professorship for the analysis of workplace and their employees. He is also the academic director of the Québec inter-University Centre for Social Statistics and member of the executive committee of the Canadian Research Data Center Network. He received his PhD in economics from Cornell University in 2001, and is a Fellow at the IZA and CIRANO. His recent work has appeared in *Industrial Relations: A Journal of Economy and Society*, the *Journal of Economic and Management Strategy*, the *Journal of Human Capital*, and *Explorations in Economic History*.

**Ruth Dupré** is a retired Honorary Professor at the Department of Applied Economics of HEC Montréal, the business school affiliated with l’Université de Montréal. She received her PhD in economic history at the University of Toronto in 1987. Her actual research interests are the political economy of prohibition and the regulation of alcohol in historical and international perspective. Her work has been published in journals such as *Explorations in Economic History*, the *Journal of Economic History*, *L’Actualité économique*, and the *International Journal of Cultural Policy*. She has been director of M.B.A. (1999–2003) and of Academic Affairs (2006–10) at HEC Montreal.

**Hiroshi Maeda** is currently an independent scholar residing in Japan. He holds a PhD in history from the University of Illinois at Chicago and specializes in the historical epidemiology of the United States and the social history of American hospitals. He is currently examining the 1918 influenza pandemic in the context of the epidemiologic transition.

**Anders Ottosson** is a research fellow at the Department of Historical Studies, Gothenburg University, Sweden. His research deals mainly with the sociology and transfer of knowledge, history of medicine, and the emerging professions of the nineteenth century. He has published widely on the developments of physical therapy, physical education, and orthopedics. He is currently finalizing a monograph on osteopathy's and chiropractic's epistemological and therapeutical roots in nineteenth-century Europe.
