Doctoral Dissertations on Russia, the Soviet Union, and Eastern Europe Accepted by American, Canadian, and British Universities, 1977–1978

The temporary conclusion arrived at over the last three years about doctoral research on Russia and the Soviet Union having reached a plateau seems to have substance. Since it is close to the end of the decade, perhaps a final judgment can be delayed until then. This year's list contains two hundred and eighty-two titles, with one from 1948, one from 1972, five from 1975, sixteen from 1976, one hundred and seventyfour from 1977, and eighty-five from 1978 to date. One of the reasons final judgment about the growth of doctoral output on Russia and the Soviet Union is held in abeyance is because of the growing number of universities which have discontinued their earlier practice of compiling master lists; as a result, the compiler does not have complete access to current lists. In addition, responses to the author's requests are often forwarded after his deadline date. Because degrees are also granted by most universities past the usual spring commencement, with some as late as December, and because of the very late appearance of American Doctoral Dissertations (by as much as two years) and a publication deadline, complete coverage for the 1978 calendar year is not possible at this time. Ninety-four universities are represented (eightysix in the United States and eight in Canada).

The listing for Eastern Europe contains one hundred and two dissertations from fifty-four American and four Canadian universities. The separate British list is unusually large this year with ninety-one items from nineteen universities, twelve of which have produced only one item. Examination of the recently published Retrospective Index to Theses of Great Britain and Ireland 1716–1950, vol. 1: Social Sciences and Humanities, ed. Roger Bilboul and Francis L. Kent (Santa Barbara, Calif.: ABC-Clio Press, 1975), enabled the compiler to add twenty-three titles from as early as the 1920s onward, which had not been included in any of the earlier listings. The University of London alone is represented in the list with more than 40 percent of the total number.

For a list of dissertations accepted through 1959 see Jesse J. Dossick, Doctoral Research on Russia and the Soviet Union (New York, 1960). An accompanying volume 2, Doctoral Research on Russia and the Soviet Union, 1960–1975 (New York: Garland Publishing Inc., 1976) is also now available. Volume 2 contains not only the more than three thousand titles which have appeared in the listings published annually in the December issue of Slavic Review since 1964 (the 1964 listing also included dissertations accepted in 1960–63), but also items not previously listed in volume 1. In addition, volume 2 offers some critical and statistical analysis, over thirty major classifications, numerous sub- and sub-subclassifications, cross references, an index of Russian and Soviet names, and an index of authors.
