

## CONTRIBUTORS TO THIS ISSUE

RICHARD COOPER is Assistant Professor of History at the University of North Carolina, Wilmington. This article grew out of research for his dissertation on British war finance 1793-1807. At present he is completing a study of George Rose, Pitt's right-hand man and Secretary of the Treasury from 1783-1801.

RICHARD L. GREAVES is Professor of History at Florida State University. His publications include *Society and Religion in Elizabethan England* (1981), *Theology and Revolution in the Scottish Reformation* (1980), *The Puritan Revolution and Educational Thought* (1969), *John Bunyan* (1969), *Elizabeth I, Queen in the Seventeenth Century* (3 vols., ed. with Robert Zaller, 1981-82), *John Bunyan: A Reference Guide* (with James Forrest, 1982), *The Miscellaneous Works of John Bunyan* (Oxford English Texts, vols. 2, 8, 9, 11), and many journal articles. Currently he is working on Protestant Nonconformity and radical politics in Stuart England.

PETER IVER KAUFMAN is Assistant Professor and Director of Undergraduate Studies in the Department of Religion at the University of North Carolina, Chapel Hill. He is the author of *Augustinian Piety and Catholic Reform* (1982), and of articles on fifteenth and sixteenth-century religion and culture, in *Church History*, *Sixteenth Century Journal*, *Medievalia et Humanistica*, and *Patristic, Medieval and Renaissance Proceedings*. He has also written on nineteenth-century British historiography and on medieval soteriology. At present he is working on a book-length study of religion and early Tudor politics, 1485-1516.

J. M. McEWEN is Professor of History at Brock University, St. Catharines, Ontario. His articles have appeared in *Queen's Quarterly*, *Dalhousie Review*, *The Journal of Modern History*, *The Historical Journal*, and the *Bulletin of Historical Research*, as well as in the *Journal of British Studies*. He is now working on a full-length study of relations between the national press and the political and military leaders in Britain during the First World War.

JEROME MECKIER is Professor of English at the University of Kentucky. He has published essays on Dickens, George Eliot, Aldous Huxley, and Evelyn Waugh. His book on Huxley appeared in 1969. He is a founding member of the Dickens Society and currently serves as a trustee. He has been an editor of *Dickens Studies Annual* and Book Review Editor of *Dickens Studies Newsletter*.

ELLEN MORE is Assistant Professor of History, part time, at the University of Rochester and at Nazareth College. Her doctoral dissertation, "John Goodwin and his Coleman Street Congregation in Cromwellian England" (University of Rochester, 1980), is being revised for publication as *The New Arminians*. She is also engaged in writing a chapter on "Women and the Radical Sects in Seventeenth Century England" for a book on Women and Protestantism to be edited by Richard L. Greaves.

BARBARA J. PEARDON is Tutor in British History at the University of Queensland. She has written articles on the use of the computer in historical research, and is at present studying the polemical literature provoked by the supremacy of the Crown in the English church from 1529 to 1570.

CLAYTON ROBERTS is Professor of History at the Ohio State University. He is author of *The Growth of Responsible Government in Stuart England*, of *A History of England* (with David Roberts), and numerous articles on Stuart politics. He is now working on a book on the decline of personal monarchy in late seventeenth-century and early eighteenth-century England.
