1. Mathematical Proceedings (ISSN 0305-0041) issues one part every two months. Two volumes of three parts are published each year. The subscription price (which includes second-class postage) of volumes 93 and 94 (1983) is £46.00 net per volume (U.S. \$110.00 in the U.S.A. and Canada).

2. Scope of the Mathematical Proceedings. Papers which advance knowledge of mathematics, either pure or applied, will be considered by the Editorial Committee. The work must be original and not submitted to another journal. Papers should be sent to the Editor, Mathematical Proceedings, Cambridge Philosophical Society, Bene't Street, Cambridge CB2 3PY, England. Papers in languages other than English should be sent only after prior consultation with the Editor.

3. *Correction of proofs.* If a paper is accepted, the author will receive in due course page proofs for him to correct and return within one week. To minimize disturbance of type, when words or phrases are added in proof, others of equal length should be removed if possible.

If many corrections are made in the proofs, the Council reserve the right to charge the cost.

4. Authors get free offprints, 50 in covers or 100 without, and may obtain more on payment. An order form is sent with the proofs.
