

The last male Catarina pupfish Megupsilon aporus, photographed in the laboratory of Christopher Martin at the University of California, Berkeley. Extinctions are occurring at an unprecedented rate as a consequence of human activities. The freshwater Catarina pupfish, endemic to Mexico and the sole species of the genus Megupsilon became extinct in 2014, despite efforts to maintain the species in captivity by the Martin lab and others. The loss of this species has evolutionary and ecological implications, and highlights the crisis of freshwater fish extinctions. To conserve the c. 200 freshwater fish species threatened with extinction in Mexico the country urgently needs a national strategy with improved policies for ecosystem management and water use.
