THE CONTRIBUTORS

DANIEL BELL, a Fellow of the Center for Advanced Study in the Behavioral Sciences in Stanford, Calif., during the past year, will become Associate Professor of Sociology at Columbia University in September. A collection of his political essays, with the tentative title *The End of Ideology*, will be published in the late fall.

DANKWART A. RUSTOW, Associate Professor of Public Law and Government at Columbia University, until recently held a similar position at Princeton, where he was also a Research Associate of the Center of International Studies and a staff member of the Program in Near Eastern Studies. He is the author of *The Politics of Compromise* (1955) and a contributor to *Islam and the West* (1957) and *Foreign Policy in World Politics* (1958).

MALCOLM W. HOAG, a staff member of The RAND Corporation, will be on the faculty of the National War College in 1959-1960. He was Assistant Professor of Economics at the University of Illinois in 1948-1950 and subsequently served as an economist with the Marshall Plan Mission to the United Kingdom.

HEDLEY BULL is Assistant Lecturer in International Relations at the London School of Economics and Political Science. He is engaged in research on the theory of international relations and on military and disarmament questions.

C. P. KINDLEBERGER, Professor of Economics at the Massachusetts Institute of Technology, is a member of the editorial board of *World Politics*. His most recent book is *Economic Development* (1958).

MYRON RUSH is a staff member of The RAND Corporation and author of *The Rise of Khrushchev* (1958). At present he is doing research on the role of the economic bureaucracy in Soviet politics during the Stalin succession crisis.

WILLIAM DIEBOLD, JR., Director of Economic Studies at the Council on Foreign Relations in New York, has been working on problems of European economic integration since 1947. His new book, *The Schuman Plan* (1959), is in some respects a sequel to an earlier study, *Trade and Payments in Western Europe* (1952).

KLAUS EPSTEIN is Assistant Professor of History at Harvard University. The author of *Matthias Erzberger and the Dilemma of German Democracy* (1959), he is at work on a history of German conservatism from the French Revolution to the First World War.
