





As part of an ongoing movement toward concerns over community access to data employed in empirical enquiries, and the related possibilities for replication and cumulation, the editors will require authors whose articles are accepted for publication to ensure that their data are fully accessible. Authors of quantitative empirical articles must make their data available for replication purposes. A statement of how that is done must appear in the first footnote of the article. Required material would include all data, specialized computer programs, program recodes, and an explanatory file describing what is included and how to reproduce the published results.


