New Jion Pittsburgh WEIMAR PRUSSIA, 1918-1925:

THE UNLIKELY ROCK OF DEMOCRACY by Dietrich Orlow

Dietrich Orlow demonstrates that the success of democracy in Germany's largest state was not accidental, but rooted in the dynamics of its nineteenthcentury history. Until 1918 Prussia's key role as the rivet of national unity gave the Conservative Junkers a power monopoly. After the collapse of the empire, the moderate groups that had gained dominance—Catholics, Liberals, and the Social Democrats—co-operated to establish and preserve a democratic government in order to prevent the return of Conservative rule. Hence the paradox that Germany's most reactionary state became after World War I a showcase for the viability of parliamentarism in Germany. As a 1924 Social Democratic pamphlet claimed, Prussia was a "democratic . . . solid rock."

Professor Orlow, Chairman of the History Department at Boston University, draws on extensive research in government archives and in the private papers and memoirs of Prussian leaders for the first full-length examination of Weimar Prussia in English.
