Her recent work also includes articles on industrial rehabilitation in the Côte d'Ivoire, technological change in the global textile and clothing industries and the evolution of strategic partnerships in the European information technology industry. She has served as consultant to, among others, the Canadian International Development Research Centre (IDRC), the French Commissariat General du Plan, UNIDO, UNCTAD, UN Economic Commission for African and the OECD.
