TENSE, REFERENCE, AND WORLDMAKING James A. McGilvray

The tenses of natural languages are intimately connected with the abilities we have to relate real or fictional stories that take place outside our immediate temporal or spacial context. While philosophers and cognitive scientists have had difficulty coming to terms with these abilities, James McGilvray maintains that they must be understood before an adequate view of what a tense is can be constructed.

Using Reichenbach's (1947) theory of tenses and temporal structures as a point of departure, McGilvray modifies it to produce a theory of his own. Analysing the difficulties Reichenbach's theory has in explaining the relationship of a speaker to a world, he introduces a new model for this relationship based on the three-interval temporal topology that Reichenbachian theory assigns to the sentences of natural languages.





Single quotation marks should be used except where there is a quotation within another. The titles of books and journals should be underlined (i.e. to be printed in italics), as should foreign words. Titles of articles should be in single quotation marks.

Notes and references will be printed as footnotes and should be typed (double-spacing) on a separate sheet, numbered consecutively. They should be referred to in the text by superscripts. Citations should be as follows:
