He is the author of Wagner's Musical Prose: Texts and Contexts (1995), as well as editor and co-author of the Cambridge Opera Handbook on Wagner's Flying Dutchman (2000), the Cambridge Companion to Wagner (2008) and Wagner and his World (Princeton, 2009). Recent projects include essays on 'absolute music', ecocritical perspectives on landscape and nature in nineteenth-century music, the entry 'Richard Wagner' for Oxford Bibliographies Online, music and the 'Gothic', and American musical theater.

Arthur Groos is Avalon Foundation Professor in the Humanities at Cornell University and a founding editor of *Cambridge Opera Journal*.

Michael J. Puri is Associate Professor of Music at the University of Virginia and is the author of the monograph *Ravel the Decadent: Memory, Sublimation, and Desire* (Oxford, 2011). Ravel and Wagner are central to his research, particularly through the lenses of hermeneutics, memory studies and music analysis. During the 2013–14 academic year he will be a Fellow at the National Humanities Center (US), where he will be writing a book on cosmopolitanism in Ravel.

Claudio Vellutini is a Ph.D. candidate in music history and theory at the University of Chicago. His dissertation focuses on the reception of Italian opera in early nineteenth-century Vienna. Previously he studied musicology at the University of Pavia and violin performance in Cremona. In 2012 he received an Ernst-Mach Fellowship from the Österreichisches Austauschdienst, the Austrian exchange agency funded by the Austrian Federal Ministry of Science and Research.
