ince the publication of the first SETUPS — for the 1972 Election — Supplementary Teaching Units in Political Science have been widely used in political science courses. Now, there is a SETUPS on the recent presidential election. Voting Behavior: The 1992 Election by Charles Prysby and Carmine Scavo can enable students to learn how to conduct research on voting behavior.


Looking For Graduate Programs and Faculty in Political Science?
