## Revolution Postponed Women in Contemporary China

Margery Wolf. The Communist revolution promised Chinese women an equality with men in all matters legal, political, social, and economic. This book examines the extent to which this promise has been kept. Based on nearly a year of field research and interviews with over 300 women in six widely separated rural and urban areas, it gives us a vivid picture of Chinese women today—their daily lives, their views of the present, their hopes for the future. Charles O. Hucker. Premodern Chinese documents contain a great number and variety of official titles important to an understanding of traditional Chinese government but often elusive in meaning and significance. Marking a milestone in Chinese studies, this encyclopedic work translates and defines more than 8,000 personal titles and institutional names spanning the period from antiquity to the mid-19th century. Arranged alphabetically by Wade-Giles romanizations, basic entries include Chinese characters and a suggested English translation; most go on to supply historical and comparative information. # The Peasant Economy and Social Change in North China

Philip C. C. Huang. The author presents a new interpretation of the origins and nature of the agrarian crisis that gripped the North China Plain in the two centuries before the Revolution. Through a comparison of the histories of small family farms and larger scale managerial farms, the author documents and illustrates the long-term trends of agricultural commercialization, social stratification, and mounting population pressure in the peasant economy. He shows how those changes, in the absence of dynamic economic growth, combined over several centuries to produce a poor peasantry dependent upon both family farming and agricultural wage income to survive. \$35.00

#### Confidential U.S. State Department Central Files

### CHINA: Internal Affairs, 1930-1949

Covering the internal affairs of China from 1930 through 1949, the State Department's Central Files are the definitive source of American diplomatic reporting on the political, military, social, and economic developments in China. Although scholars have used these files at the National Archives for several years, the files have never been published in any format until now. By making available over 200,000 pages of special reports, confidential correspondence, interviews, minutes of meetings, and translated documents, this new collection opens broad avenues of research.

The period covered by these files was marked, in the 1930s, by bitter civil war between Kuomintang and Communist forces, by military intervention by Japan, and by the temporary consolidation of rival Chinese forces against Japan. In the 1940s, the hard-fought victory against Japanese occupation was followed by resumption of the civil war, failed mediation attempts by the U.S., and seizure of power by the Communists. These political and military developments, as well as social and economic ones, were observed and reported by American diplomatic personnel throughout China, both at the U.S. embassy and at consulates (Amoy, Canton, Chefoo, Foochow, Hankow, Harbin, Mukden, Nanking, Shanghai, Swatow, Tientsin, Tsinan, Tsingtao, and Yunnanfu). These reports are the largest component of the Central Files. Additionally, there are reports from the State Department's Division of Far Eastern Affairs, as well as reports on China from such other U.S. diplomatic posts as Tokyo, Saigon, Hanoi, Calcutta, London, Paris, Berlin, and Moscow.

Now available in a convenient microfilm edition, the State Department's Central Files on Chinese internal affairs will be counted among the most useful research collections in any library. Filmed from the original documents in the National Archives, our edition contains all of the important files; only files of little or no historical value (such as those dealing with claims of U.S. citizens) have been omitted.

The "publication" of the State Department's Confidential Central Files on China's internal affairs is a monumental event which adds new dimensions to the study of China in the 1930s and 1940s. Used together with Chinese Nationalist and Communist materials, as well as Japanese, Russian, British, German, and French sources (when available), the availability of these Central Files could open a new era of intensive multi-archival research on China. A thorough re-examination of Chinese history in the 1930s and 1940s is in order.
