## Subscriptions

*New Testament Studies* (ISSN 0028-6885) is published four times a year in January, April, July and October. Four parts form a volume. The subscription price, which includes delivery by air where appropriate plus electronic access to institutional subscribers (but excluding VAT), of volume 67 is £285 (US \$489 in USA, Canada and Mexico) for institutions and £76 (US \$123 in USA, Canada and Mexico) for individuals. Students may subscribe at £29 (US \$50 in USA, Canada and Mexico). Single parts are £78 net (US \$133 in USA, Canada and Mexico) plus postage.
