Council for Latin America, 5th Annual Membership Meeting Washington D.C., May 6, 1969 Latin American leaders in the fields of labor, education, business and government addressed this meeting and North Americans

added their comments. Arturo Jauregui, Secretary General of the Inter-American Regional Organization of Workers spoke for the Latin American labor movement; Reinaldo Scarpetta of the University del Valle, Colombia spoke on education; Israel Kabin, the Brazilian industrialist discussed the business scene, and Eduardo Roca, Argentine Ambassador to the U.S. reviewed the progress, problems and prospects of government in Latin American. North American commentators were, respectively: William C. Doherty Jr. of the American Institute for Free Labor, Peter F. Drucker, and William E. Barlow, President of CLA. Assistant Secretary of State Charles E. Meyer concluded the proceedings with informal remarks at lunch.

20th Annual Latin American Conference, Gainesville Florida, February 25–28, 1970 See LARR V.i. "Universities in Transition" was the theme of this conference, the first of a series under the general heading: "The

U.S. Presence in Latin America," sponsored by the Center for Latin American Studies, University of Florida. The primary purpose was to interpret and evaluate U.S. influenced changes in Latin American higher education during the past decade. A working nucleus of a dozen scholars, half of whom were from Latin America, spent the first two days listening to and discussing papers they had prepared; official observers were admitted and participated at the end of each session. Atcon of the Department of Educational Affairs, OAS discussed Integrated University Reform. Speaker at the luncheon was Luis Alberto Sánchez, former Rector of San Marcos University, Lima. His subject was: Views on Latin American Higher Education. Dr. Sanchez also gave the Latin American viewpoint in Period IV: The Relevance of U.S. Models for Latin American University Development. Period V was devoted to a preliminary discussion of final reports and a public address by John U. Crimmins, Deputy Assistant Secretary of State for Inter-American Affairs, State Department on the subject: Toward a More Mature Partnership: The Nixon Administration's Latin American Policy. Tjarks, Visiting Professor from Argentina at the University of Florida and Part II: North American Report by George Waggoner, Dean of the University of Kansas.
