How have regimes used the agencies of criminal justice for their own purposes? What characterizes the linkage of politics and justice? Communism in Czechoslovakia, 1948-1960*By Edward Taborsky*

Once considered Central Europe's model democracy, Czechoslovakia has since 1948 been a Soviet satellite. The Communists boast that their system has defeated capitalism politically and has surpassed it in production, in living standards, and in social justice. How realistic is this picture of conditions in a country once oriented to the West? In attempting to answer this question, Professor Taborsky reviews the history of the Communist Party's rise to power and examines in detail the economic, social, political, and cultural programs of their regime, comparing stated plans with actual results through 1960. His final assessment of the Party's grip on Czechoslovakia measures both effort and result against the human cost. 592 pages. Tables. \$12.50
