SUBMITTING PAPERS

Papers should be sent to The Editor, *British Journal of Nutrition*, 10 Cambridge Court, 210 Shepherds Bush Road, Hammersmith, London W6 7NJ. They should be written concisely and must represent the results of original nutritional research or a new interpretation of existing knowledge not previously published. Full requirements and details of how papers should be prepared are given in Directions to Contributors printed in Part I of each volume but authors should also consult a recent issue to acquaint themselves with the style and conventions of the Journal. Submitted papers (four copies) should be accompanied by a signed statement to the effect that the author accepts the conditions laid down in Directions to Contributors.

Subscriptions. For non-members of The Nutrition Society the subscription including postage (excluding VAT), to volumes 75 and 76, 1996 of the *Journal*, is £310.00 payable in advance to Cambridge University Press, The Edinburgh Building, Shaftesbury Road, Cambridge CB2 2RU, or to any agent.
