His influence in molding the temple city of Puri can still be noticed today. The book is based on Bengali and Sanskrit sources besides fresh sources in Oriya and throws light on the life of Chaitanya in Orissa, the influence which the sect founded by him exerted there and also its relationship with Vrndāvan, in the homeland of Kṛṣṇaim. The book constitutes an important addition to the knowledge of the history of religion in Orissa and India.
