Spanish Islamic Architecture and Latin American Architecture: Stylistic Influence of Cordoba Mosque on the Conception of Churches.

A study of the influence of the structure of space and plan of Cordoba's great mosque on the development of a peculiar Spanish style that modifies the classical Gothic plan of churches, how it influenced the Seville Cathedral, among others, and how this passed to the conception of Latin American churches. A minor aspect of this research treats the tradition of the *transparentes* and their origin in the Mirab, in particular that of Abderraman III. EDC, 1972.

Post-Olmec Sculpture in Preclassic Oaxaca.

A study of the survival and revival of Olmec art forms in Oaxaca, Mexico, 300-500 years after the Olmec civilization had died out in Veracruz. Study concentrates on ceramic effigy vessels and the monumental low relief slabs from Monte Albán known as the "Danzantes." The Izapan art style of low relief carving helps supplant the Olmecoid motifs, especially through the newly-discovered ceremonial center of Dainzú in Oaxaca Valley. Concludes with a survey of other art styles deriving from Olmec forms, and proposes the term Post-Olmec styles for these manifestations. Begun, 1967. EDC, 1972. /Foreign Area Fellowship Program. A related study, "Before Cortés: Sculpture of Middle America," with Elizabeth K. Easby, was published by the Metropolitan Museum of Art, 1970.
