This study describes the formal role of law school training in the preparation of lawyers and considers how this role affects the legal profession as a whole. Drawing on a survey of about 550 practicing lawyers in Chicago, it connects in-school and in-practice experiences to assess professional schooling within the context of socialization. Tables present data on variations in background, type of law school, nature of practice, and years at the bar, and the relations of these variables to motivation for entering the profession, academic performance, evaluations of law schools' contributions to skills and knowledge important to law practice, and perceptions of professional responsibility.

Integrating their findings with those of other empirical studies, the authors appraise criticisms of formal legal education and various proposed reforms.

Research Contributions 1981, No. 2 A PROPOSED ACT TO REGULATE LEGAL EXPENSE INSURANCE

Recently, interest in legal expense insurance, also known as prepaid legal services, has grown among consumers, employers, and especially insurers. We can thus expect increased pressure on state legislatures to smooth the way for this new form of coverage. It is therefore an opportune time for a new edition of the proposed model act that the authors prepared in 1977 for the National Association of Insurance Commissioners. The authors believe that legislative action is necessary to remove the uncertainty in many states about the regulatory requirements and restrictions applicable to legal expense insurance, and to provide a regulatory framework within which legal service financing and delivery systems can freely develop while the public is adequately protected against unsound or fraudulent schemes. The model act is accompanied by comments on individual sections and is preceded by an introduction, which sets out the authors' regulatory philosophy on legal expense insurance and legal service plans generally.
