## PUBLISHING AND SUBSCRIPTION INFORMATION

*Environmental Conservation* is published by Elsevier Sequoia S.A., Lausanne, for the Foundation for Environmental Conservation, with the collaboration of the International Union for Conservation of Nature and Natural Resources (IUCN), International Association for Ecology (INTECOL), International Conferences on Environmental Future (ICEF), World Environment and Resources Council (WERC), World Wildlife Fund (WWF), and others. It is covered in about twelve international contents and abstracting journals emanating from Great Britain, the United States, Italy, and West Germany.

*Environmental Conservation* is published quarterly, corresponding to the four seasons in the Northern Hemisphere.
