Annual Review of Applied Linguistics

First published in the Spring of 1981, the Annual Review of Applied Linguistics is intended to serve working scholars and their graduate students in the various sub-fields of applied linguistics. The design of the book provides brief state-of-the-profession articles together with annotated and unannotated bibliographies of key references, with particular attention to material published in the preceding year.

Each volume of *ARAL* has a specific theme. Volume I[1981] attempted to provide a broad review of the whole of applied linguistics; it included articles on: Bilingualism, Pidginization and Creolization, Structuro-Cognitive Approaches to Pedagogy, Notional/Functional Approaches to Pedagogy, Computer Assisted Instruction, Psycho-linguistics, Error Analysis, Language Acquisition Research, Language Testing Research, Sign Language, Sociolinguistics, Macrosociolinguistics and Microsociolinguistics. Volume II [1982] has attempted to explore applied linguistic problems related to the international movements of peoples for whatever reasons. Specifically, it examines language policy, language-in-education policy, and education practice in 19 separate articles covering some 30 countries.

Volume III [in production, scheduled in 1983] will be devoted to problems in written discourse. A bibliographic index will be provided beginning with Volume III. Volume IV [being planned at the moment, scheduled for 1984] will be concerned broadly with literacy, and Volume V [planned for 1985] will return to the basic overview used in Volume I. At this point, planning has not gone beyond 1985.

The ARAL brings together the work of outstanding scholars and provides a rapid bibliographic reference to the most important work being produced in the various sub-fields of applied linguistics. Publication is supervised by an editorial board including Alison d'Anglejan, Braj Kachru, Ron Cowan, and G. Richard Tucker. The General Editor is Robert B. Kaplan.
