





- Reviews should be double-spaced on A4. Footnotes should be numbered
 consecutively, although references should normally be incorporated in the text, not in
 footnotes, which should be used as sparingly as possible. At the end of the review your
 name should be given in capitals on the right hand side, your institution (or home
 town) underlined or italicised on the left.
- 2. Please send your review as an e-mail attachment to classicalreview@classicalassociation.org. If you use a word-processing package other than Microsoft Word, or if you use a Mac computer, it would be a useful precaution to paste the review into an e-mail message as well as sending it as an attachment. If your review contains Greek or any other special characters, please supply a pdf file as well, or send a hard copy by post to Classical Review, The Classical Association, Senate House, Malet Street, London WC1E 7HU, UK; otherwise it is not necessary to send a hard copy. Greek should, if possible, be typed in Unicode using Porson font. Submissions by e-mail will be acknowledged on receipt.
- 3. Quotations in English, Latin, French, etc., should be put in single inverted commas. A quotation within a quoted passage has double inverted commas. Single words or self-contained phrases (such as *fait accompli*) may be underlined to indicate italics. Material inserted within a quotation is placed in square brackets.
- 4. References should normally be given in the following form:
