# Remaking America

Public Memory, Commemoration, and Patriotism in the Twentieth Century

### John Bodnar

In a compelling look at popular commemorative events—ranging from ethnic community fairs through Civil War reenactments to celebrations of our pioneer past—John Bodnar examines American public commemorations from the early nineteenth century to the present day.

Noting a strong tendency on the part of authorities to promote national patriotism through public commemorations, Bodnar finds that ordinary citizens want these events to reinforce personal sentiments and concerns—of class, race or ethnicity, sex, regional identity, and family. *Remaking America* is filled with the stories behind American celebrations and monuments as Bodnar charts the creation of "public memory" over the course of more than a century.
