SUBMITTING PAPERS

Papers should be sent to The Editor, *British Journal of Nutrition*, 10 Cambridge Court, 210 Shepherds Bush Road, Hammersmith, London W6 7NJ. They should be written concisely and must represent the results of original nutritional research or a new interpretation of existing knowledge not previously published. Full requirements and details of how papers should be prepared are given in Directions to Contributors printed in Part 1 of each volume but authors should also consult a recent issue to acquaint themselves with the style and conventions of the Journal. Submitted papers (four copies) should be accompanied by a signed statement to the effect that the author accepts the conditions laid down in Directions to Contributors.
