

CONTRIBUTORS TO THIS ISSUE

James W. Alexander, Associate Professor of History at the University of Georgia, has published a monograph on Herbert of Norwich (1091-1119) in *Studies in Medieval and Renaissance History*, Vol. VI (1969). He is at work on a biography of Earl Ranulf III "de Blundeville," Earl of Chester (1188-1232).

Kenneth D. Brown is Assistant Lecturer in the Department of Economic and Social History, Queen's University, Belfast. This is his first published article.

J. C. Davis, Senior Lecturer at the University of Waikato, New Zealand, has recently published two other articles and is at present writing a book concerning English utopian thought in the early modern period.

Lawrence Kaplan is Assistant Professor of History at City College of the City University of New York. He has published other articles on mid-seventeenth-century topics and was on a postdoctoral fellowship last summer at the University of California, Los Angeles.

Sally Jean Marks, Assistant Professor of History at Rhode Island College, is publishing another article and is at work on a book, both dealing with the period immediately following World War I.

P. J. Perry is Senior Lecturer in Geography at the University of Canterbury, New Zealand. He has published an article and is engaged in research on aspects of European agricultural history.

Pat Rogers, who has just moved from Sidney Sussex College, Cambridge, to be Lecturer in English at King's College, University of London, has a book, *Grub Street*, appearing this year. His other scholarly activities include a forthcoming book on literature and society, 1688-1760, and articles on Pope, Defoe, Swift, Steele, and Sterne, published or forthcoming.

Alexander Tyrrell, recently of the University of New England in New South Wales, is now Lecturer in History at La Trobe University, Melbourne. He has published an article on the Scottish working class in the early nineteenth century and is soon to publish another article on Samuel Smiles.
