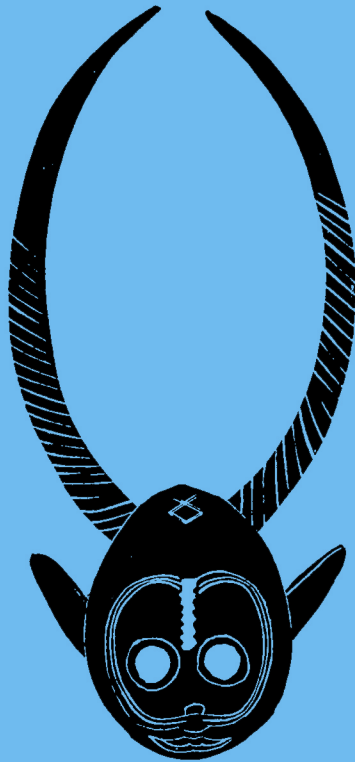

The *Review* will only consider manuscripts that have not been published elsewhere and are not being considered by other journals.
