Gerichtshof decisions, and only 20 percent of the Verwaltungsgerichtshof. Most decisions are heavily edited before publication. Decisions of the Oberlandesgerichte are not reported, except that some of them are published in law reviews on a random basis.

Belgium The appellate courts consist of:

- Cour de Cassation (Court of Cassation)
- Conseil d'Etat (Council of State)
- Cours d'Appel (Courts of Appeal – five in number)

Decisions of the Cour de Cassation are reported on a selective basis in an official series. Presumably all important decisions of the Conseil d'Etat are published privately. There is no regular publication system for the decisions of the Cours d'Appel.

Federal Republic of Germany The appellate system is quite intricate as there are six specialized and mutually exclusive court hierarchies:

- Bundesverfassungsgericht (Federal Constitutional Court)
- Bundesgerichtshof (Federal Court of Justice)
- Bundesarbeitsgericht (Federal Labour Court)
- Bundessozialgericht (Federal Social Court)
- Bundesfinanzhof (Federal Court of Finance)
- Bundesverwaltungsgericht (Federal Administrative Court)
- Verfassungsgerichte der Länder (State Constitutional Courts)
- Bayerisches Oberstes Landesgericht (Supreme Regional Court of Bavaria; there are no courts of this resort in the other states)
- Oberlandesgerichte (Higher Regional Courts – 19 in number)
- Oberverwaltungsgerichte (Higher Administr. Courts – 10 in number)
- Finanzgerichte (Finance Courts – 13 in number)
- Landesarbeitsgerichte (Higher Labour Courts – 12 in number)
- Landessozialgerichte (Higher Social Courts – 11 in number)

The reporting practice in the Federal Republic of Germany is extremely varied. Except for certain decisions of the Federal Constitutional Court, which are officially published by the Ministry of Justice, the only official series of law reports exists for the Federal Court of Finance, where about 27 percent of its decisions are published on a selective basis. In terms of practical reality, however, this statement is inaccurate. Private series of reports exist for each of the above federal courts. Though they do not have an official imprimatur, they are invariably published under the editorial supervision of the judges sitting in the respective courts. The series for the Federal Constitutional Court contains full texts of all decisions of that court. The reporting for the other federal courts is more selective with the ratio of published decisions ranging between 50 and 60 percent. Similar situation prevails for subordinate appellate courts on state or regional levels, though
