Development Administration

CONCEPTS, GOALS, METHODS

George Gant

Since the 1950s, governments of the world have sought to improve the social and economic conditions of their citizens. George Gant uses the term "development administration" to cover the complex of agencies, management systems, and processes which have become necessary to strengthen all levels of government activity towards the goals of each country. In *Development Administration: Concepts, Goals, Methods*, the author uses his experience of twenty-five years in the field to give an overview of the shape that development administration has taken and to point to the shape it should take in the future.

The change from "undeveloped" or "underdeveloped" to "developed" is not a condition that can be pinpointed, but it does mean more than simply the eradication of poverty. Gant defines development as the process of increasing the choices and opportunities individuals have in planning and leading their lives according to personal ideas of happiness and fulfillment.

Gant devotes specific chapters to studies in planning, budget, personnel, agriculture, population, education, nation building, public enterprises, and regional and local organization. He also offers fresh and interesting observations on the qualities needed by an administrator who must

synchronize development in all these areas, and categorizes the types of training for personnel according to purpose and the organization. Additional chapters deal with the impact of foreign aid and the growing global bureaucracy upon national development policies.

The theoretical framework of the chapters is elucidated and amplified by the practical examples Gant draws upon from his experience. The indexes and bibliographies also make this book an important reference to the literature available, and to a variety of organizational and administrative issues.

George Gant was, until his recent retirement, visiting professor in the Department of Political Science at the University of Wisconsin-Madison, and an academic advisor for the University of Wisconsin Center for Development. He has written widely on public policy and the administrative sciences, and has served as a consultant on several planning boards in Asian countries. During his long and distinguished career, he served the Tennessee Valley Authority for sixteen years (General Manager, 1946-51) and the Ford Foundation for another sixteen (1955-71).



Threat Perception in International Crisis

Raymond Cohen

Since the early days of the Cold War, the problems of threat perception and its role in international relations have engrossed political scientists, psychologists, historians, and foreign policy practitioners. Raymond Cohen's *Threat Perception in International Crisis* offers an important preliminary study of the subject, clarifying the nature of that perception with his systematic investigation of case studies to illustrate and test important theoretical and practical questions.

To ascertain what common factors affect threat perception, Cohen applies the methodology of comparative analysis to six widely separated incidents in modern Western European and American history: "The War in Sight" crisis of 1875, involving French perceptions of an impending invasion by Germany under Prince Bismark; the Italian invasion scare of 1889 in which Italian Prime Minister Crispi was convinced of the imminence of a French invasion by sea; the Limon von Sanders affair of 1913 when a German military mission to Constantinople was viewed with consternation in St. Petersburg and alienated Russia from Germany in the prelude to the 1914 war; British perception of a German threat as a result of Hitler's breach of the Munich Agreement; the Corridor crisis of March, 1939, resulting from

aggressive German proposals to Poland regarding Danzig; and the Turkish Straits crisis of 1946, when American statesmen perceived a threat of Soviet seizure of control in Turkey.

On the basis of these case studies, Cohen finds and discusses the complex, interlocking elements that govern the perception of threat: conceptual clarifications, predispositional factors, process of judgment, imagery of threat, effects of personality, public opinion, politics, and the rules of the game.

Cohen compares the international system to a community or social system which, if still very primitive, is subtly balanced and ordered with an explicit and implicit network of restraints. In a dangerously uncertain world, these "rules of the game" regulate permissible behavior among the actors.

Raymond Cohen is a Teaching Fellow in the Department of International Relations at the Hebrew University of Jerusalem. He is the co-author of several articles on international relations that have appeared in *Comparative Politics*, *International Social Science Journal*, and *Political Science Quarterly*.


