### AWARDS AT THE 1986 E. H. A. MEETING

At the 1986 Annual Meeting of the Economic History Association, held in Hartford, Connecticut, September 26–28, the following prizes were awarded:

The Arthur H. Cole Prize for the outstanding article published in the JOURNAL in the September 1985 through June 1986 issues, to Roger L. Ransom of the University of California at Riverside and Richard Sutch of the University of California at Berkeley, for their article, "The Labor of Older Americans: Retirement of Men On and Off the Job, 1870–1937," in the March 1986 issue. The Cole Prize recipient is selected each year by the JOURNAL's editorial board.

The Allen Nevins Prize for the outstanding dissertation in United States or Canadian economic history completed during 1985/86, to Carolyn C. Cooper of the History of Science Department, Yale University, for her "The Roles of Thomas Blanchard's Woodworking Inventions in Nineteenth-Century American Technology," completed at Yale University in 1985.

The Alexander Gershenkron Prize for the outstanding dissertation in non-United States or Canadian economic history completed during 1985/86, to Martha Shiells, Center for Naval Analyses, for her "Hours of Work and Shiftwork in the Early Industrial Labor Markets of the United States, Great Britain, and Japan," completed at the University of Michigan in 1985.

The recipients of the Nevins Prize and Gerschenkron Prize are selected each year by the conveners of the Dissertation Session at the Annual Meeting.

### MEETINGS AND CALLS FOR PAPERS

The Economic and Business Historical Society invites the submission of abstracts and papers for its twelfth annual meeting, to be held April 23–25, 1987, in San Francisco, California. Competitive proposals should be sent to Professor Paul Tiffany, President and Program Chair, EBHS, Wharton School, 2027 Dietrich Hall, University of Pennsylvania, Philadelphia, PA 19104–6370. Abstracts are due January 23, 1987, and papers are due March 20, 1987. Abstracts should be a minimum of two pages, papers a maximum of 20 pages including references. The EBHS encourages interdisciplinary scholarship in the areas of business and economic history, relative to both the United States and the world.

The second annual multidisciplinary conference on the fiftieth anniversary of World War II, sponsored by Siena College, will be held June 4–5, 1987. The focus for 1987 will be 1937, though papers dealing with broad issues of earlier years will be welcomed. Topics include fascism and Nazism, Ethiopia, Spain, literature, art, film, diplomatic and military history, popular culture, women's studies, and Jewish studies dealing with the era. Papers on the Sino-Japanese War will be particularly appropriate.

Please note that papers and panels dealing with constitutional topics viewed in a historical and comparative context are welcome, given the bicentennial of the U.S. Constitution being celebrated at the time of the meeting.

The International Society for the Comparative Study of Civilization holds its sixteenth annual meeting May 29–30, 1987, at Ohio University, Athens, Ohio. Papers are invited with special, but not exclusive, emphasis on the themes of: 1) Civilizational Encounters and the Transformation of Ideologies, 2) Marxism as a Methodology for the Comparative Study of Civilization, 3) Feminist Issues in the Civilizational Process, 4) Comparative Literature, 5) Violence, Terrorism, and Civilization, 6) the Civilizational Theory of Max Weber, 7) Global Civilization: What is Materializing, 8) the Family and Civilization, 9) Myth and Reality: Cosmogonic and Escatological Theories of Civilization, and 10) Time: Comparative Perspectives in Civilization. Seven copies of a one-page abstract should be sent to Wayne Bledsoe, Program Chairman, ISCSC 1987, Department of History/Political Science, University of Missouri-Rolla, Rolla, Missouri 65401.

The First International Congress on the Hellenic Diaspora from Antiquity to Modern Times will meet during the spring of 1988. The conference will be divided into four sections: 1) Ancient (to 330) 2) Late Antiquity/Mediaeval (330–1453) 3) Early Modern (1453–1774) 4) Modern (1774 to present) The first two sections will take place in Montreal and the last two in Athens during the spring of 1988. Organization of the conference will be directed by a steering committee, and an editorial committee will supervise publication of the proceedings in the series *McGill University Monographs in Classical Archaeology and History*. ### **RESEARCH FELLOWSHIPS**

The Hagley Museum and Library announces its third year of fellowship study funded by the National Endowment for the Humanities and the Andrew W. Mellon Foundation. Two fellowships, available for the 1987/88 academic year, offer exceptional opportunities to study American industrialized society since 1850.

The fellowship program is designed to promote integrative and comparative research into the social context and consequences of industrialization of the United States in the century following 1850. Scholars from any humanistic discipline or from related social sciences are encouraged to apply for the two available fellowships. The minimum residency is six months and the maximum stipend is \$25,000 for an academic year. Under Endowment guidelines, N.E.H.-funded fellowships may not be awarded to degree candidates or for study leading to advanced degrees.

A scholar to undertake an edition of the economic writings of Jeremy Bentham is sought by the University of Chicago and the Bentham Project of University College, London. The project, which is being funded by the Bradley Foundation, will require

work in both Chicago and London. The stipend is \$25,000 per year. Applicants should possess a general familiarity with the history of political economy and a taste for deciphering difficult handwriting. They should write in the first instance to Professor R. H. Applications are invited for the Eileen Power and Michael Postan Awards in social and economic history for the session beginning October 1987. The Eileen Power Award is a studentship, and preference will be given to candidates who propose to undertake research in the economic or social history of any period of some country other than the country of their usual residence. The Michael Postan Award is intended to provide financial support for research students of any nationality in the form of a studentship, travel expenses, or any other expenses of research.

Each award is for as much as £600 and will be tenable for one year. It may be held with other awards and is not conditional on registration for a higher degree. Application forms and further details may be obtained from the Scholarships Officer, London School of Economics and Political Science, Aldwych, London WC2A 2AE. The closing date for applications is March 31, 1987. If there are candidates of sufficient merit, awards will be made in July 1987.
