AT a General Meeting of the Camden Society held at the Freemasons' Tavern, Great Queen Street, Lincoln's Inn Fields, on Friday, the 2nd of May, 1851,

THE LORD BRAYBROOKE, THE PRESIDENT, IN THE CHAIR,

THE President having opened the business of the Meeting,

The Secretary read the Report of the Council agreed upon at their meeting of the 16th of April, whereupon it was

Resolved, That the Report of the Council be received and adopted, and that the Thanks of the Society be given to the Council for their services.

It was moved by Mr. Bruce, seconded by Mr. Collier, and resolved unanimously,

That this meeting desires to express its profound regret at the deprivation sustained by the Society in the death of Thomas Amyot, Esquire, its first Director, and wishes to convey to his Family its deep sympathy on their irreparable loss.

The Secretary then read the Report of the Auditors, agreed upon at their Meeting of the 29th of April, whereupon it was

Resolved, That the said Report be received and adopted, and that the Thanks of the Society be given to the Auditors for their services.

REPORT OF THE COUNCIL

OF

THE CAMDEN SOCIETY,

ELECTED 2nd MAY, 1850.

THE COUNCIL of the Camden Society, elected on the 2nd May, 1850, have to report that, acting on the principles heretofore observed, they have invested two compositions received during the present year, and that the stock standing in the names of the Trustees of the Society has thereby been increased from £921 18s. to £942 12s. Three per Cent. Consols. Although the Council believe that the object for which the Society was established, and a maintenance of the principles upon which it has hitherto endeavoured to attain that object, afford the best security for the permanence of the Society, it is a matter of congratulation to the Council, as it will no doubt be to the Society at large, to find an additional security for such permanence in the satisfactory amount which the reserved sum is gradually attaining.

distinguished Members—namely, Thomas Amyor, Esq. the first Director of the Society. The Council have recorded on their Minutes the very sincere respect and regard which they all entertained for their deceased colleague and fellow-labourer, and their sense of the zealous and valuable services which he rendered to the Society at its formation, and so long as the state of his health allowed. The Council feel that in so doing they only gave utterance to a sentiment shared by every Member of the Society.

The death of Mr. Amyor having occasioned a vacancy in the directorship, the Council, in pursuance of the authority vested in them by their laws, unanimously elected to that office Mr. Bruce, who during the many years in which he had acted as Treasurer of the Society, and by the works he had edited, had given the best possible proof of the interest he takes in its welfare.

And it would be happy to find other Gentlemen willing to undertake an office the labours of which are very trifling, while the advantages to the Society from the establishment of an increased number of such coadjutors would be very considerable.

The publications issued during the past year have been-

I. Wills and Inventories from the Registry of the Commissary of Bury St. Edmund's and the Archdeacon of Sudbury. Edited by Samuel Tymms, Esq.

This volume has, we believe, been received with much satisfaction by the Members, not only as the first one illustrative of Testamentary Documents which has been issued by the Society, but also because it is looked on as an evidence that, if the time should ever arrive when the important documents of this valuable class now deposited at Doctors' Commons may be made available for the historical student, the Camden Society will be ready to use all the means at their disposal for giving them to the world.

II. Walter Mapes De Nugis Curialium. Edited by Thomas Wright, Esq. A work of great curiosity and value, containing many facts and historical anecdotes relating to an early and very important period of our history.

III. The Pylgrymage of Sir Richard Guylforde to the Holy Land, A.D. 1506. From a copy believed to be unique, from the press of Richard Pynson. Edited by Sir Henry Ellis, K.H., Sec. S.A.

A curious work, upon a subject at all times of great interest.

The Council have added the following works to the List of Suggested Publications:—

I. A Collection of Letters of Queen Elizabeth, the Earls of Leycester and Burghley, and Secretary Walsingham, from the originals in the State Paper Office. To be edited by John Bruce, Esq.

This collection of Documents, which was suggested by Mr. Adlard, is of great historical importance, and will form a supplement volume to the Leycester Correspondence, already edited by Mr. Bruce.

II. Early Treatises on the subject of the Advantage of having a Vernacular Translation of the Scriptures. To be edited by SIR FREDERICK MADDEN, K.H., F.R.S. Keeper of the Manuscripts, British Museum.

The Council have reason to believe that the Tracts to be contained in this volume, the publication of which was suggested to them by SIR FREDERICK MADDEN, as soon as he had brought to a close his long and valuable labours on the Wickliffite version of the Holy Scriptures, will be found strikingly illustrative of the history of opinion in the important period to which they relate.

III. The Domesday of St. Paul's; a Description of the Manors belonging to the Church of St. Paul's in London in the year 1222. To be edited by the Ven. Archdeacon Hale.

The learned Archdeacon of London having expressed his willingness to edit for the Camden Society this curious document, the Council readily embraced the offer, glad of the opportunity of securing the publication of so important a record under the editorial supervision of a gentleman so peculiarly fitted for the task.

In bringing to a close this account of their stewardship during the past year, the Council trust that the Society will see, both in the Works which have been issued to the Members, and in those which have been projected, not only that due regard has been paid to the important objects for which the Camden Society was originally instituted, but also unquestionable evidence of the service which it is by such publications daily rendering to historical students, and its consequent claim to be regarded as among the most useful and the most popular of the literary institutions of the country.
