# URBAN SOCIAL INSTITUTIONS Ph.D. Program

The University of Wisconsin-Milwaukee has announced a new doctoral program in Urban Social Institutions. USI is an interdisciplinary Ph.D. program intended to produce scholars capable of sophisticated and useful social science research. The program emphasizes the institutional, theoretical and empirical tools necessary for policy-relevant research in the social complex that constitutes the urban milieu. Students completing the program will be qualified for research and policy positions in a variety of governmental agencies, private industry, and in traditional academic posts.

Because of the interdisciplinary nature of the program, students will have great flexibility in mastering substantive areas built around a theoretical and research core. Areas of specialization include methodology, theory, institutional change, social structure and change, urban growth and development, race and ethnicity, policy and future analysis and service delivery systems, urban history, nonconventional behavior.

The requirements for admission to the program are: (1) a Master's degree or the equivalent in social science or a related field; (2) statistical proficiency of an intermediate grade (e.g., through correlational analysis and tests of significance); (3) first-hand experience of research with primary data; (4) a solid background in urban studies within some disciplinary framework (e.g., urban sociology, urban history, urban planning or the like). Should the entering student be inadequately prepared in one or the other areas, he/she may be admitted with the provision that the work be made up either before entering the program or concurrently with the first year's residence.

Urban Social Institutions began its first year in September, 1977. A limited number of students will be admitted for 1978. Some teaching and project assistantships will be available. ## HANDICAPPED Directory

The Project on the Handicapped in Science of the American Association for the Advancement of Science (AAAS) is developing a directory of scientists with handicapping conditions which will be distributed to public agencies, handicapped scientists, and consumer organizations to facilitate communication among them. Research for, and publication of the directory is supported by the National Science Foundation (Grant No. SP177-19913).

Each directory entry will contain basic personal and professional biodata, nature and age of onset of handicapping condition, and a summary of educational and professional experience including problems faced and overcome. The scientists will be asked if they would be willing to act as advisors, consultants and/or evaluators on many levels concerning science and the handicapped. This information will also be included in the directory. It is anticipated that the directory will identify handicapped scientists of specific scientific specialization who are willing to share experiences and information on coping strategies; educate the scientific community concerning their existence and their problems; organize action when needed; and provide the basis for problem analysis and professional planning for scientific societies, educational institutions, consumer organizations, and federal agencies.

The project defines science broadly to include all the natural and social sciences, mathematics,

engineering and medicine—all fields for which a rigorous scientific education is required. It will seek to include those with degrees in these areas or equivalent training who are working in scientific, medical or technological fields. The directory will also include individuals trained in science but working in other areas or presently unemployed.

At this time the AAAS has names of over 500 disabled scientists who have been serving as a resource group to the Association. The Association is interested in increasing this number so that the directory will include as many handicapped scientists as possible. #### **FEMINIST** Publications

The Barnard College Women's Center has announced the publication of the two major papers from the fourth annual conference held at Barnard on April 23, 1977, The Scholar and the Feminist IV: Connecting Theory, Practice, and Values.

"The Social Implications of the Scientific Study of Sex," by Diana Long Hall, is a case study of the way in which knowledge in a new field is created. In this paper Ms. Hall, an historian of science in the departments of history and biology at Boston University and a Fellow of the Radcliffe Institute 1976-77, examines the way in which accepted, biased assumptions about science and sex roles affected the development of the field of sex endocrinology in the late 19th and early 20th century United States.

The second paper, "Is Traditional Scholarship Value Free? Toward a Critical Theory," by Mary E. Payer, a social philosopher and a Chamberlain Fellow in Philosophy at Columbia University, analyzes the broader social and theoretical implications of the specific day-today scientific and scholarly practices discussed by Hall. By examining such concepts as "science," "knowledge," and "interest," the paper clarifies the ways in which fundamental assumptions can bias the entire enterprise of scholarship.

#### CONGRESSIONAL Studies Program

The Catholic University of America, in conjunction with the U.S. Capitol Historical Society, is offering a program in Congressional Studies leading to a Master of Arts degree. The program, directed by Professors Norman J. Ornstein of the Department of Politics and Jon L. Wakelyn of the Department of History at Catholic University, will emphasize historical and contemporary approaches to Congress and the U.S. political system. Courses which have been or are currently being taught include History of the U.S. Congress, the Budget Process, Rules and Procedures in Congress, U.S. Government Reorganization, Congressional Elections, Congress in Theory and Practice, and the Congressional Committee System. Instructors in the program have included Terence T. Finn, Iric Nathanson, Walter Kravitz, Thomas Mann, Michael J. Malbin, William Maury, Norman J. Ornstein, and Rep. Charles Whalen (R-Ohio).

#### **GERMAN** Politics Group

The Conference Group on German Politics (CGGP), an independent voluntary organization of scholars who devote a major portion of their professional work to the study of German affairs, sponsored a roundtable on the 1976 German Election at the recent APSA Convention with papers presented by David Conradt, University of Florida, Kai Hildebrandt, University of Michigan, and William Andrews, SUNY, Brockport. In collaboration with country groups on British, French and Italian Politics, the CGGP also sponsored panels on separatism/ regionalism and on current European economic policies.

A study group composed of nine CGGP members with specialized interest in legal affairs, civil liberties and public opinion traveled to the Federal Republic in December for a two-week tour sponsored by the German Information Center, New York and Inter Nationes, Bonn. Purpose of the trip was to assay the impact of recent terrorist incidents on mass opinion, elite opinion and on the self-understanding of professional groups such as law enforcement officials, lawyers and judges.

Preliminary plans are underway for an international conference of scholars to be held June 5-9, 1978 at Tutzing, Bavaria on the topic: "Participation and Politics: Comparative Public Policy." Plenary sessions and working groups will focus on issues in the policy areas of education, energy, urban politics and health. The conference is being cosponsored by the Studiengruppe Partizipationsforschung of the University of Bonn and the Tutzing Akademie fuer Politische Bildung. Alfred Diamant of Indiana University is American co-chairman for the conference.

The CGGP continues to sponsor a limited number of internships and scholars-in-residence awards in cooperation with German public and private offices. Leslie Sternberg, a graduate student at SAIS, and Professor George Szablowski of York University, Ontario, are currently in Germany on CGGP-sponsored programs. Deadline for 1978-1979 awards was January 13, 1978.

#### ICPSR Summer Program

The Inter-University Consortium for Political and Social Research (ICPSR) Summer Program is designed to encourage the diffusion to social scientists of basic and advanced methodological and technical training. Intensive inter-disciplinary work for historians, political scientists, sociologists, and other social scientists is provided through a set of two four-week courses. Instruction is offered in least squares-regression, causal inference, dimensional and dynamic analysis, and exploratory data analysis. In addition specialized two-week workshops are given on specific methodological problems, as well as on data management, librarian, and archival procedures. The Program also provides access to training in the techniques of survey research and mini-micro computer utilization.

The need for a training program arose out of the realization that few universities or colleges are able economically to maintain a curriculum in quantitative inquiry that meets the full range of needs for social scientists today. The Summer Program provides a wide range of advanced specialized training for graduate students and post-doctoral participants in most of the techniques of analysis currently employed by social scientists, plus opportunities for introductory work in modern social analysis for those whose careers or educational opportunities did not provide such training.

The ICPSR curriculum has evolved into a modular program of methodological and technical training that seeks maximum topical and disciplinary relevance. While primarily methodological in focus, the Program differs from conventional statistics curricula in two respects: it is designed to convey technical skills as an integral part of a broader context of substantive social inquiry, and it is oriented toward an active, learning-by-doing mode of training and instruction. Experiences in data processing and the analysis of data in individual or small group projects complement lectures and discussions in most of the courses. Introductory sequences are offered for students and teachers needing basic skills. Intermediate level courses provide scholars with an opportunity to become familiar in depth with a wide variety of analytical techniques. Additionally, advanced seminars offer participants experience with innovative methods and techniques often not yet readily available in published form.

#### The Profession

#### Program Design

The Program is conducted for eight weeks each July and August. It is structured into two sets of four-week modules designed to provide a flexible and challenging instructional format. The participants select seminar and workshop modules according to their main interests, and supplementary lectures to receive overviews and exposure to areas other than those chosen in the seminars and workshops. Participation in the Summer Program is counted as the equivalent of up to six graduate credit hours. An individual participant's program may consist of various combinations of seminar and/or workshop modules, supplemented by lecture modules as desired.

Methods Seminars: The objective of the intensive methods seminars is to provide the participant with the opportunity for a focused and intensive experience in the application and adaptation of specific quantitative research and analysis techniques. The four-week modules include:

Proseminar in behavioral research methods: research design, elementary data analysis.

Methods of general statistical analysis: least squares, nominal data, multi-level analysis, recent developments in data analysis.

Techniques of causal inference: causal inference, recent developments in causal modeling.

Techniques of dimensional analysis: factor analysis, multi-dimensional scaling, recent developments in dimensional analysis.

Techniques of dynamic analysis: time series, panel analysis, process modeling.

Seminar in quantitative methods of historical analysis.

Exploratory data analysis.

Research Workshops: The workshops are designed to provide each participant with an opportunity for intensive experience in the application of research methods to either a general substantive area or a specific substantive problem of scholarly interest. Specific subjects are amended from year to year; they have typically covered such topics as the following: Political alienation, black political behavior, mass media and the political process, elite-mass linkages, undergraduate teaching, political economy, public policy evaluation.

Two of the several special workshops which will be offered during the 1978 Summer Program will focus on (a) quantitative analysis of *criminal justice problems* utilizing archival resources developed with the support of the Law Enforcement Assistance Administration, and (b) quantitative analysis of *issues on aging* drawing upon archival resources developed with the support of the Administration on Aging.

An intensive two-week workshop on data management procedures will also be given. This workshop will concentrate on data archival, librarian, and servicing techniques. General Lectures: Supplementary lectures are intended to give an exposure to concepts and ideas in areas other than those covered by an individual participant's primary selection of seminar modules. Lecture modules offered include: Topics in general statistical analysis, causal inference, dimensional analysis, dynamic analysis, topics in formal political theory, and elementary and advanced mathematics for social scientists.

Related Programs: While the ICPSR Summer Program focuses on methods of data analysis rather than data collection, the SRC Summer Institute offers training in the methodology of survey research: study design, sampling, questionnaire construction, interviewing, coding, and analysis. Interested participants should avail themselves of the opportunity to attend the program conducted by the Survey Research Center (which is held concurrent with the ICPSR Summer Program), or to select courses from both programs.

In addition, an intensive one-week seminar on "Mini and Microcomputers: Their Structures, Characteristics and Applications" will be conducted in conjunction with the University of Michigan Engineering Summer Conference in late July for those interested in learning about the latest developments in this area of hardware and technology.

## **RANN** Symposium

The *Proceedings of the RANN 2 Symposium*, presenting results of the November 1976, Second Symposium on Research Applied to National Needs (RANN), have been released by the National Science Foundation.

The RANN 2 Symposium was designed to bring together researchers, users of research in industry and government, and science policymakers at the national, state, and local levels to report on current and prospective RANN activities over a broad range of areas and to foster the interchange of ideas and concerns between users and providers of research.

#### MYRDAL Prizes

The Evaluation Research Society will welcome nominations for its Myrdal Prizes honoring Gunnes and Alva Myrdal.

It is in their spirit that the Evaluation Research Society offers three Myrdal prizes for outstanding leadership and distinguished achievement in government, the sciences, and the human services.

In government, the prize is awarded for creative and original leadership in the conceptualization and sponsorship of new intellectual work in the field of evaluation. In 1977 this Prize was awarded to Dr. Howard R. Davis, Chief, Mental Health Services Development Branch, NIMH.

In science, the prize is given to the individual having made a significant contribution to advancing the conceptualization or development of methodologies used in evaluation research. In 1977 this Prize was awarded to Dr. Donald Campbell, Professor of Psychology, Northwestern University.

In human services delivery, the prize is given to the individual who has done the most to upgrade service delivery through the application of evaluation. In 1977 this Prize was awarded to Dr. Julius Richmond, Assistant Secretary for Health, HEW.

Nominations are solicited for each of these three prizes to be awarded next year. Nominations of individuals, including supporting material regarding their achievements, should be sent no later than May 1, 1978, to the Chair of the Myrdal Prizes Committee: John R. Barry, Department of Psychology, University of Georgia, Athens, Georgia 30602.

Final selection of the prize winners from among the nominations received will be made by majority vote of the Myrdal Prizes Committee. Awards will be presented at the Annual Meeting of the Evaluation Research Society in Washington, D.C. in October 1978.

#### **INTERFUTURE** Program

Interfuture, a non-profit educational organization conducting programs for college students for cross-cultural research abroad will focus its 1978-79 projects on Surinam, Belgium, Britain, Holland, Ireland, Ivory Coast, Jamaica, and Ghana.

InterFuture study projects range over many fields, including social sciences, peace studies, humanities, history, education, environmental studies, the arts, business, urban problems, ethnic and women's studies, the media, and public health. IF Scholars have designed study projects on such topics as multinational corporations, blac, theater, folk arts, sports exchanges, labor-management relations, educational reform, rural development, sickle cell anemia testing programs, nutrition, family planning, the elderly, political protest groups, ocean pollution, wildlife preservation, and television news analysis.

Once a student selects a topic, InterFuture gives her or him a network of support which includes training conferences, continuing advice, and international contacts. Credit-worthiness of each student's project is determined by his or her home college or university as part of work toward the bachelor's degree. Nearly 100 students have been InterFuture Scholars since the program was established in 1969.

## JUDICATURE Journal

Judicature, the refereed journal of the American Judicature Society, is published ten times a year and circulated to 33,500 judges, lawyers, social scientists, and others concerned with the effective administration of justice. Manuscripts submitted for consideration should normally be 15-20 double-spaced typewritten pages, but longer and shorter manuscripts will be considered. Footnotes should be used in moderation, not as extensively as in a law review article. Two copies of the manuscript are required. Authors are notified of the referees' decision within 30 days and most accepted articles are published within six months.
