TWO NEW BOOKS

The Buried Pyramid

ZAKARIA GONEIM

Dr Zakaria Goneim, the discoverer of the buried pyramid of King Sekhem-Khet at Sakkara, Egypt, has entrusted us with the publication of the first definitive book on the discovery.

Dr Goneim's book, written with the assistance of Mr Leonard Cottrell, describes how he came upon the hitherto unknown monument, and how he penetrated at last to the Sarcophagus Chamber, which proved to be a 'dummy burial' for the King's spirit. Dr Goneim believes that the real burial chamber of the King, and other subterranean galleries and chambers, will be disclosed, and that new light will be thrown on a remote and little-known period of Egyptian history.

The Shrine of St Peter and its Ancient Setting JOCELYN TOYNBEE, M.A., D.PHIL. and JOHN WARD PERKINS, M.A., F.B.A.

Of the many riddles that lie hidden under the soil of Rome, none has aroused deeper interest than the tradition that the remains of St Peter are buried beneath the high altar of his great church. Not until 1939, however, was systematic excavation started. Now the huge church stands shored-up on piers—a formidable feat of engineering—and beneath it a whole area of pagan and early Christian tombs of incomparable interest, both intrinsically and for their rich evidence of social and religious beliefs, has been revealed. This book is the first serious and detailed study of these discoveries as a whole; and the authors have been able, thanks to the Vatican authorities, to study on the spot everything that they describe.

With regard to the shrine of the Apostle—about which there has been much erroneous and sensational speculation—the authors write that their aim has been 'to offer a straightforward and objective account of the facts as revealed by the excavations, and to present their own interpretation of those facts'

Professor Toynbee is Laurence Professor of Classical Archaeology at Cambridge University, while Professor Perkins is Director of the British School at Rome.
