



# The Justice of the Peace in England, 1558-1640 A LATER EIRENARCHA

By JOHN H. GLEASON, Pomona College, Claremont, California. William Lambarde's Etrenarcha, a book about the Justices of the Peace, appeared in 1582. Using a diary which Lambarde kept as a key to one county bench and taking it as a gauge of others, Professor Gleason examines the commissions of the peace for Kent, Norfolk, Northamptonshire, Somerset, Worcestershire, and North Riding between 1558 and 1640. He analyzes them with reference to the social and economic status of members, the circumstances of their appointment and continuance in office and the parts played by religion and politics. \$8.75

## The Liberal Party and the Jameson Raid

By JEFFREY BUTLER, Wesleyan University. The book examines the factors behind the Jameson Raid and why the South Africa Committee of 1897 failed to properly investigate it. Butler uses the private papers of front Benchers, defines the problems of the Liberal leaders and describes the conflict between personal and political motives that led up to the inquiry which appeared so bogus to contemporaries. \$6.75

## Paradise Lost and the Genesis Tradition

By J. M. EVANS, Stanford University. This study first traces the development of the rich and complex tradition out of which Paradise Lost emerged, from its source in the Book of Genesis. It then proceeds through the early Jewish and Christian writings on the Fall and the subsequent Latin and Old English poems on the subject, to its treatment in literature of the Middle Ages and the Renaissance. In the last section of the book this wealth of traditional material is applied to a close critical reading of Paradise Lost, emphasizing not only Milton's indebtedness to that tradition, but also his profound originality. \$6.75

## The Poems and Songs of Robert Burns

Edited by JAMES KINSLEY, University of Nottingham. In this edition all Burns' surviving poems and songs are published together, for the first time, with the airs for the songs in their eighteenth-century form. The text is based on a critical revision of nearly 800 manuscripts and the early printings, and includes songs collected or amended by Burns. It is accompanied by a textual Introduction, a critical apparatus and a literary and textual commentary. (Oxford English Texts.) In three volumes, \$26.50

The Journal of British Studies, founded in 1961, is published at Trinity College under the auspices of the Conference on British Studies. It was the result of the imaginative generosity of a Trinity alumnus, Frederick E. Hasler (Hon. LL.D. 1957) who contributed funds to the College for the specific purpose of establishing a learned periodical in the field of British history. Several Trinity alumni subsequently contributed to the fund and Trinity College now supports the publication of the Journal.

The Conference on British Studies is the official organization in the United States and Canada of scholars working in the field of British history and culture; its status as such is recognized by the American Historical Association of which it is an affiliate. Its nearly eight hundred members are drawn from forty-eight states and five provinces. It convenes twice each year at New York University, its permanent headquarters.

The Conference awards a prize triennially for the best first book by an American or Canadian scholar.

The Conference sponsors a considerable publications program. It publishes the *Journal of British Studies* at Trinity College; the *British Studies Intelligencer*, a newsletter, at Kansas State University, Manhattan, Kansas; *Studies in British History and Culture*, an annual series of monographs, at the University of Bridgeport, Connecticut; *Archives in British History and Culture*, an annual series devoted to the publication of documents, at West Virginia University, Morgantown; and *Current Research in British Studies*, a quadrennial survey of research in progress in the United States and Canada, the next edition of which will appear in 1968 at Southern Methodist University. The Conference has begun a new series, to be published by the Cambridge University Press, of biographical and historical studies of men and women who were makers and shapers of the English experience.

In addition to the Conference on British Studies, there are three affiliates: the Pacific Coast Conference on British Studies, the Midwest Conference on British Studies, and the Southern Conference on British Studies. Each of these vital autonomous groups has its own officers, program, and other activities. There are also local groups centered in San Francisco, Los Angeles, Detroit, and Pittsburgh.

The Journal of British Studies appears twice in the academic year, in the autumn and in the spring. The annual subscription is \$5.00. # CONFERENCE ON BRITISH STUDIES PRIZE
