The style and arrangement should conform to current practice in the Proceedings. References, including titles of papers, should be given in the form adopted by Mathematical Reviews, footnotes being avoided if possible. Figures should be separated from the text and lettered, ready for photographic reduction; their intended location should be clearly indicated. Manuscripts which are not suitable for submission to the printer will not be accepted. Authors are advised to retain a copy of any material submission to the Society cannot accepted. A proof is supplied once. Authors are particularly requested to correct and return the proof promptly. Excessive corrections may be charged to authors.
