Weed Science (ISSN 0043-1745) is an official publication of the Weed Science Society of America, 810 East 10th Street, Lawrence, KS 66044-8897 (785-843-1235). It contains refereed papers describing the results of research that elucidates the nature of phenomena relating to all aspects of weeds and their control. It is published bimonthly, one volume per year, six issues per year beginning in January.

Membership is \$85 per year, student affiliate membership \$30, which includes receipt of Weed Science, Weed Technology, and WSSA Newsletter. Dues should be sent to WSSA, 810 East 10th Street, Lawrence, KS 66044-8897 not later than December 1 of each year. Membership in the society is on a calendar-year basis only.
