With rapid developments taking place in radiotherapy practice, increasing workloads, the drive to provide efficient cost effective services and in the climate of a UK shortage of therapy radiographers, we are delighted to present two guest editorials.

Both authors, Sue Griffiths with 'Therapy radiography staffing for the treatment and care of cancer patients' and Stephanie McWilliam with 'Cutting work at the cutting edge', present papers on alternative staffing models. Departmental managers are required to address the needs of the patient and the complex requirements of the service, whilst being accountable for scarce resources. Both authors would very much value comments and debate on the issues they raise and we would like to publish some of your letters, so please write in. The contents and abstracts for the Journal are also available on the website, as well as instructions to authors for anyone interested in submitting an article.

In this issue we have an original article from John Newnham in which he defines the role of spiral CT in evolving an evidence-based 3D conformal radiotherapy prostate protocol. John also critiques the current literature and identifies the need for undertaking further study relating the localisation, delivery and verification of the treatment of prostate cancer.

To continue the theme of conformal treatment, David Flinton and P. Desai examine and compare the financial costs of conventional radiotherapy for cancer of the prostate with those incurred in undertaking conformal radiotherapy.

In the article presented by Dana Dudek and colleagues, the authors undertake a review of the

literature and outline their methodology for a study of the role of Aloe vera gel in the management of radiation induced skin reactions for postoperative primary breast cancer patients.

Amanda Gee and her colleagues continue the theme of skin care in a paper describing a randomised controlled trial to test a nonmetallic deodorant used during a course of radiotherapy. The results are very detailed and make interesting reading.

Angela Cross and Peter Salmon present a paper on the physical side effects experienced by women with breast cancer: the women's perspective. The authors research the women's perspectives on the treatment side effects; they highlight the need for good sources of accurate information for this group of patients.

To conclude this issue we have a technical note, presented by Andrew Seaby and C. Craven. This technical note provides practical information on the construction and properties of a variable shielding block for irregularly shaped megavoltage X-ray fields.

As the first volume of the Journal of Radiotherapy in Practice is completed, the editors would like to thank the members of the Editorial Board for their enthusiasm and contribution to development of the Journal.
