John Broome is Reader in Economics at the University of Bristol. He is the author of *Weighing Goods* and *The Microeconomics of Capitalism*. He is now writing a book about the value of living.

Neil de Marchi is Professor of Economics at Duke University. He is editing a volume of papers on the implications for the way historians of economics approach their material following the publication of Philip Mirowski's *More Heat than Light*.

James Devine is Associate Professor at Loyola Marymount University in Los Angeles. He specializes in macroeconomics, political economy, labor economics, and economic history.

Gary Dymski is Assistant Professor of Economics at the University of California, Riverside. He has published a series of papers, many co-authored with John Elliott of the University of Southern California, on exploitation and economic democracy under capitalism. He has also written extensively on banking, financial fragility, and the LDC debt crisis.

Juan Hersztajn Moldau is Professor of Economics at the University of São Paulo. His major area of interest is microeconomics, especially the theory of choice, the theory of production, and economic welfare. He has also published work on international economics.

Frank Jackson is Professor of Philosophy at the Research School of Social Sciences, Australian National University. He is the author of *Perception* and *Conditionals*, as well as of many articles in philosophy.

Maarten Janssen is Assistant Professor of Economics at the Erasmus University Rotterdam. His *The Relation between Micro and Macro in Economics* is forthcoming, and he has published articles in *The History of Political Economy* and *The Journal of Macroeconomics*. He teaches microeconomics and economic methodology.

Maurice Lagueux is Professor of Philosophy at the Université de Montreal. His publications include studies of the methodology of economics and history, Marxism, liberalism, and the philosophy of architecture; he teaches philosophy of economics and philosophy of history.

Hans Lind is Assistant Professor of Economics at Stockholm University. He is active in the methodology of economics, with a special focus on the use of simplifications in economics; and in experimental economics, including quasi-experimental policy evaluations and laboratory experiments.

Philippe Mongin is a senior research fellow with the Centre National de la Recherche Scientifique in Paris and currently holds a joint position at the Université Catholique de Louvain, Belgium. His work is concerned with the philosophy of the social sciences, the history of economics, and formal choice theory. He has published articles in a variety of French- and English-language philosophy and economics journals.

Julie A. Nelson is Assistant Professor of Economics at the University of California, Davis. She is author of several articles on the empirical analysis of household demands. Her current work includes analysis of consumption using the Consumer Expenditure Survey; she is co-editor of a work-in-progress on feminist theory and economics.

Philip Pettit is Professor of Social and Political Theory at the Research School of Social Sciences, Australian National University. He is the author, with John Braithwaite, of *Not Just Deserts: A Republican Theory of Criminal Justice*; his *The Common Mind: From Intentional Psychology to Social and Political Theory* is forthcoming.

John Roemer is director of the Program on Economy, Justice, and Society and Professor of Economics at the University of California, Davis. He is currently working on aspects of political economics, including models of market socialism and public ownership. He has published four books on Marxian economics.

Hyun Song Shin is Fellow in Economics at University College, Oxford. He has worked in the areas of the foundations of game theory and problems of uncertainty and information in economics.

Elliott Sober is Hans Reichenbach Professor of Philosophy at the University of Wisconsin, Madison. He is the author of *The Nature of Selection: Evolutionary Theory in Philosophical Focus* and *Reconstructing the Past: Parsimony, Evolution, and Inference*, both published by MIT Press.

Irwin P. Stotzky is Professor at the University of Miami School of Law. He is author of *The Theory and Craft of American Law – Elements* and numerous articles on issues of constitutional adjudication. His current interest is in philosophical and methodological approaches to constitutional interpretation.

Yao-Hua Tan is a researcher in the Department of Mathematics and Computer Science at the Free University of Amsterdam. The subject of his research is formal analysis and applications of non-monotonic reasoning.
