German Expressionist Prints ca.1880-1933 These important prints record how the distinctive language of 20th c. printmaking was created, largely by the young artists of Die Brücke extending the limits of Edvard Munch's work. Also included are prints by Max Klinger, Käthe Kollwitz, and the artists of Der Blaue Reiter and the Bauhaus.

American Prints ca.1880-1960

The prints range from those produced under the shadow of Whistler, through the divisions of Modernists, Regionalists, and artists of the American Scene in the 1920s and '30s, to the work of Jackson Pollock and Jasper Johns in 1960.
