Report of Council for the year 1998

INTRODUCTION

Objects

The primary objective for which the Society is established is to promote and further the study of the history and philosophy of science. Secondary objectives include the provision of facilities, the arrangement of meetings, the promotion of research and the publishing of papers; full details of all the objectives may be found in the Society's *Memorandum of Association*.

Policies

The main policy of the Society is to provide the infrastructure to gain its objectives and in approved cases to provide financial assistance by which its members and others may benefit in some aspect of their activities whilst helping to achieve the objects of a learned Society.

To achieve this overall policy, the Society maintains a world-wide membership, issues several publications, chief of which is the *British Journal for the History of Science*, holds regular meetings and conferences on the history of science, technology and medicine, and contributes where appropriate to debate at governmental and other levels on scientific and educational issues.

In terms of direct financial benefits, membership for students, the retired and the unemployed is subsidized, and reduced charges and bursaries are available for students attending conferences. Travel costs, especially for overseas meetings, are often met for individual members and others. There is a biennial essay competition, the winner of which is awarded the Singer Prize worth £300. The Dingle Prize, also worth £300, is another biennial award for the best recent history of science book on a theme to be determined by the Council. Both prizes are open to members and non-members. Several publications are free to both members and non-members; members enjoy reduced charges for some publications.

Organization

The controlling body of the Society is its Council. Several sub-committees are responsible to Council for various activities described below and several members of Council have an Officer post designated for a specific responsibility. Council is advised by a number of Advisory Officers in specialist roles and by the Executive Secretary. The Executive Secretary is also the Company Secretary and is responsible for the day-to-day administration of the Society, including keeping the accounts. The Executive is under contractual terms, reviewed annually by Council. No member of Council or the Society receives any remuneration for services to the Society but expenses are paid.

1. Postgraduate Meeting, 7-8 January 1998, Science Museum, London

This meeting brought together graduate students working in the history of science and related disciplines to present their work informally and to meet other researchers. 2. The History of Scientific Textbooks, 10 January 1998, Leeds University

Organized jointly with the Colloquium on Textbooks, this meeting brought together historians working on textbooks in science. Papers were given by M. Honeybone, J. Issitt, I. Michael, C. Sutton, J. Topham and E. R. Vera. The meeting was organized by Dr John Issitt and Prof. Geoffrey Cantor.

3. P. M. S. Blackett: Science and Politics in Twentieth Century Britain, 16–17 April 1998, Imperial College, London

Organized jointly with Imperial College, Manchester University, the Operational Research Society and the Royal Society, this meeting considered the career and work of P. M. S. Blackett. The meeting was also the venue for the Society's EGM.

5. Gender and Science, 11 July 1998, St Edmund Hall, Oxford

This meeting was devoted to recent work on gender and science. Papers were presented by J. Browne, S. Forgan and G. Gooday, A. Morrison-Low, M. Roper and A. Winter (whose contribution was read by H. Small). The meeting was organized by Prof. Ludmilla Jordanova and Dr Katherine Watson.

6. Anthropology and Psychology: The Legacy of the Torres Straits, 1898–1998, 10–12 August 1998, St John's College, Cambridge

This meeting explored the historical significance of the Torres Straits Expedition of 1898. It was organized jointly with the following: the Royal Anthropological Institute, the Department of Social Psychology, London School of Economics, the British Psychological Society, St John's College, Cambridge, the Department of Experimental Psychology, University of Cambridge, the Department of Social Anthropology, University of Cambridge and the Museum of Archaeology and Anthropology, University of Cambridge. Anniversary Fellow

Ms Anna-Katherina Mayer completed approximately nine months as the BSHS Anniversary Fellow undertaking research on the history of science in Britain as an oral history project with some 29 interviewees who had been engaged in history of science and all born between 1908 and 1939. 58 tapes have been transcribed and nearly all are fully accessible to scholars.

Publications

Four issues (Volume 31, Parts 1–4) of the British Journal for the History of Science were published under the editorship of Dr Janet Browne. The Journal was sent to members as part of the subscription benefit and was published separately at £91 (UK) and \$154 (overseas) for the Society by Cambridge University Press. Dr Frank A. J. L. James produced three issues of the Society's Newsletter during the year (Nos. 55, 56 & 57). The Newsletter was free to members, and was available to non-members at £8 (\$15) per year. Dr Sophie Forgan compiled the 28th List of Theses in History of Science (1997–98). The List, which was free to members, was available at £6 (\$11) to non-members. The fourth edition of the Guide to History of Science Courses in Britain, compiled by Dr Janet Browne, was still available free to members and non-members; the fifth edition is scheduled for 1999. Dr Isobel Falconer edited three issues of the Education Section's newsletter Education Forum during the year (Nos. 24, 25 & 26). Forum is free to members and non-members.

NOTES TO THE ACCOUNTS FOR THE YEAR ENDED 31 DECEMBER 1998

1. Accounting Policies

The financial statements have been prepared under the historical cost convention, as modified by the revaluation of investments, and are in accordance with applicable accounting standards, and the Charities Accounting Statement of Recommended Practice (Sorp). There have been no changes in the accounting policies.

a. Corresponding amounts: the corresponding amounts have been reanalysed to ensure consistency with the Sorp.

- **b.** All grants and voluntary income are accounted for gross when receivable, as long as they are capable of financial measurement. This includes gifts in kind, included at estimated valuation.
- c. All expenditure is accounted for gross, and when incurred.
- **d.** Direct charitable expenditure includes the direct costs of the activities and depreciation on related assets. Where such costs relate to more than one functional cost category, they have been split on either an estimate time or floor space basis, as appropriate.
- e. Support costs comprise service costs incurred centrally.
- f. Fixed Assets are included at cost or valuation: there are no uncapitalized fixed assets.
- g. Description is provided to write off the cost or valuation, less estimated residual values, of all fixed assets except freehold land, over their expected useful lives. It is calculated at the following rates:
 Equipment and Fittings 15% reducing balance
- h. Stocks are valued at the lower of cost or net realizable value.
- i. Designated funds are amounts which have been set aside at the discretion of the trustees for a specific, but not legally binding, purpose.
- j. All investments are stated at market value.

The company is limited by guarantee and does not have a share capital. The members undertake to contribute a sum, not exceeding $(\pounds 1)$, to the assets of the company in the event of the company being wound up.
