

Democratization in Africa examines the state of progress of democracy in Africa at the end of the 1990s. The past decade's "third wave" of democratization, the contributors argue, has been characterized by retreats as well as advances. In some cases, newly established democratic orders have devolved into pseudo-democracies while, in other cases, superficial changes have been used as a cosmetic screen for continuation of often brutal regimes. The volume makes clear, however, that political liberalization is making significant headway.

The change in the speed and direction of Hong Kong democratization, argues So, arises from the clash of interests between service professionals (such as teachers, journalists, and lawyers) and the business sector. So highlights the crucial role played by Hong Kong's businessentrepreneurial class, which rose in power and influence, developed an alliance with the Chinese government, and slowed down democratization before the handover.



Why Governments Waste Natural Resources

Policy Failures in Developing Countries William Ascher

In this groundbreaking book, William Ascher discovers the complex political and programmatic reasons why government officials in Third World countries often willfully adopt wasteful natural resource policies. Drawing on sixteen case studies from Africa, Asia, and Latin America, Ascher goes beyond the trite answers of greed and incompetence to document how clashes among government agencies have led to results ranging from Indonesia's deforestation to the collapse of the Mexican water system, from the destruction of cocoa farms in Ghana to the waste of Nigeria's oil wealth.

At a time when the depletion of natural resources threatens to undermine the economic prospects of many developing countries, this book offers structural reform recommendations that get to the heart of faulty natural resource management. Amid the tragedies of squandered resources, some hopeful reverses point the way to constructive reform strategies.

The Quest for Sustained Growth

Southeast Asian and Southeast European Cases Samuel F. Wells, Jr., Barry M. Hager, Keith Crane, Paul Tibbitts, and Karen Zeitlow

This report assesses the "Washington Consensus" on liberalizing markets in pursuit of sustained economic growth. In 1997, the "Asian Economic Miracle," thirty years of rapid growth and low inflation, ended abruptly with runs on Southeast Asian currencies and a massive flight of capital, precipitating deep economic recessions. Meanwhile, the countries of Southeast Europe had been struggling to reconstruct market economies out of the shreds left by socialist economies, their efforts complicated by civil strife or war.

Both regions had been urged by international organizations to adopt a package of policies, often called the Washington Consensus, of opening domestic markets, freeing trade, and opening domestic capital markets to free movements of international capital. Did the crisis in Southeast Asia, and related crises in Russia and Latin America, call into question that advice?

To address that question, the September 17-18, 1998, conference at the Woodrow Wilson International Center for Scholars examined these two regions. Panels reviewed the roles of international institutions, central banks, and currency boards; fixing of exchange rates; opportunities and problems of foreign investment; U.S. policy and the international institutions; and financial globalization.


