Submissions for the British Journal of Anaesthetic and Recovery Nursing The British Journal of Anaesthetic and Recovery Nursing is the only specialist Journal for a group of specialist nurses.

Manuscript Presentation

- Two copies of the article are to be submitted to the editorial team. Articles can be sent on disk but in the Microsoft Word/Works format.
- Manuscripts must be typed on A4 paper, with double spacing.
- Comment or opinion articles up to 500 words.
- Clinical, management and research articles between 2500 - 3000 words. Longer articles can be published in more than one part.
- The front piece should include professional details including job title, work address and qualifications plus an abstract and passport size photograph.

Illustrations and Photographs

- Graphs and drawings should be plain drawn or computer generated on separate sheet from the text.
- Photographs should be original, with clear label on the rear. If patients are visible then written permission from them is required before publication.

References and Reference Lists

- The Harvard system is used in the journal text. i.e. Harvard (1989).
- The reference list must be placed in alphabetical order.
- ◆ The reference list should include the following: Harvard, J. (1989) How to reference
