A new directory giving information on about 703 institutes and special programs at U.S. and Canadian universities that focuses on the problems, history, and cultures of foreign countries and world regions is available. Foreign Area Programs at North American Universities: A Directory (\$22.50) is published by the California Institute of Public Affairs, P.O. Box 10, Claremont, California 91711. The institute is affiliated with The Claremont Colleges.

The book lists the name, address, and phone number of each program; its director; degrees offered, if any; special interests, both topical and geographic; and publications issued. The volume is organized by state and province, and includes a detailed index of programs by world region and country.

Compiled from a questionnaire survey and other sources, the new publication shows that by state, universities in New York have the largest number of foreign area programs (86),

tollowed by those in California (72). Overall, Latin American studies programs are the most numerous, with programs concentrated on Eastern Europe running a close second.

A sizeable number of programs deal with a single country. The USSR, China, Japan, and Canada (there are Canadian studies units on 13 U.S. campuses) lead the list. Others focus on Afghanistan, Bolivia, Brazil, India, Ireland, Italy, Korea, Mexico, the Philippines, Poland, the Ukraine, Vietnam, and Yugoslavia.

Foreign Area Programs at North American Universities: A Directory is designed to continue a series of similar guides issued by the now-defunct World Studies Data Bank and its predecessors, but in much greater detail. (The most recent of the previous guides, "Area Studies on U.S. Campuses," issued in 1974, was

preceded by two editions of "Area Studies on U.S. and Canadian Campuses: A Directory," published by the International Council for Educational Development.)

## Society for the Promotion of SCIENCE AND SCHOLARSHIP

The publication of books of high academic quality and of educational value is frequently denied because the potential market is too small, according to the Society for the Promotion of Science and Scholarship. This is most likely to be so if the author has not become established in the world of scholarly publications, and if the subject matter of the manuscript is too specialized to interest a commercial publisher, including even university presses. The Society for the Promotion of Science and Scholarship was organized in 1976 as a nonprofit corporation to publish scholarly works of quality which would not be favorably considered by commercial publishers for financial reasons.

The Society, also known as SPOSS INC., will welcome inquiries from authors who are confronted with this problem. The Corporation is tax-exempt and may not require the payment of subsidies by its authors. Although the Society is also not permitted to pay royalties to tis authors, it will reimburse them for all or part of the expenses incurred in preparation of manuscripts, doing so if, happily, a surplus is generated from sales.

#### **BROOKLYN COLLEGE Studies**

Brooklyn College School of Social Science jointly with the East European Section, Center for European Studies, Graduate School CUNY runs a three-year program on "War and Society in East Central Europe during the 18th and 19th Centuries." The first conference was held in March 1978, which discussed special subjects of both centuries. The second conference held on December 3-5, 1979, discussed the 18th century; special sessions also were held on war aims in 1914 and the issue of prisoners of war. Further conferences are scheduled for 1980 and 1981.

Selected papers are to be published in "Brooklyn College Studies on Society in Change," a series of scholarly books, by Brooklyn College Press and distributed by Columbia University Press. The first volume, War and Society in East Central Europe during the 19th and 19th Centuries: Special Subjects and Generalizations will appear in December 1979. In 1980 two additional volumes will be published: Vol. II, War and Society in East Central Europe during the 18th Century; and Vol. III, From Hunyadi to Rakoczi: War and Society in Early Modern Hungary. The general editors are Bela K. Kiraly, CUNY, and Gunther E. Rothenberg, Purdue University. An Editorial Advisory Board is chaired by Robert A. Kann, University of Vienna.

The Program (both the conferences and the publications) is international and interdisciplinary. Attention is focused on the interdependence of political, social, and economic changes and changes in national defense systems and wars in East Central Europe. The similarities, contrasts and mutual effects of warfare in Western and East Central Europe are also studied. The participants belong to the faculties and staffs of universities and other institutions of higher learning of the U.S.A., Canada, U.K., France, Austria, Poland, Hungary, Yugoslavia and Russia. While opportunity is given to young scholars to participate, the program includes the most distinguished authorities of the field. Interested scholars are invited to join.

The Program is funded by various units of CUNY, NEH, IREX, Joint Committee on Eastern Europe of the ACLS and the SSRC.

#### CONGRESS AND PRESIDENCY Center

The College of Public and International Affairs at American University recently announced the establishment of a new research and training institute, the Center for Congressional and Presidential Studies (CCPS). The Center was initiated in response to an increasing need for an integrated teaching, research and study program in Washington, D.C. that focuses on Congress, the Presidency, and their interaction. Programs are being developed for a broad audience, including students, scholars, journalists, public officials, and leaders in private and public organizations. Co-directors of CCPS are Professors James A. Thurber and Jeff Fishel.

Utilizing American University's basic resources—its faculty, programs, and students—CCPS has sponsored several activities since its inception in October, 1979 and is now planning a comprehensive agenda through 1981. The Center's location and structure will enable it to be a dynamic research and training institution focusing on topical as well as long-run issues.

A series of colloquiums and seminars on current issues facing Congress and the Presidency has been the first project undertaken. These monthly colloquiums, which permit area scholars, journalists, and others to meet in both formal and informal circumstances are a continuation of programs begun last year at The Woodrow Wilson Center.

The first two colloquiums featured roundtables on "The Mass Media in Presidential Campaigns" with discussants James Dickinson, national editor of the Washington Star, and Professor Micheal Robinson, Catholic University; "Party Leadership in the U.S. Senate," with remarks by Professor Robert Peabody, Johns Hopkins University, and Martin Tolchin, national political correspondent, *New York Times*. Two topics planned for early 1980 are "Congressional Oversight of the Intelligence Community," and "Congress and Foreign Policy." The development and distribution of a series of "Working Papers on Congress and the Presidency" is also planned for 1980-81. These papers are designed for both the scholarly community and professionals in public life. Also to begin in 1980 is a \$1000 scholarship from the U.S. Steel Foundation for students in the Master of Arts/Master of Public Administration programs who show promise for careers with Congress, interest groups or the executive branch.

Ultimately, the Center is concerned with sponsoring long-term, basic research, and short-term applied research of utility in understanding and assisting Congress and the White House. By exercising a "quick response" capacity, CCPS will be able to assist with special research on oversight, policy analysis, and institutional anal-

ysis for congressional committees, presidential commissions, and executive bureaus.

#### CARL ALBERT Center

The Carl Albert Congressional Research and Studies Center and the Department of Political Science at the University of Oklahoma are initiating the Carl Albert Congressional Studies Program at the Ph.D. level. The Carl Albert Center was established by the Oklahoma Regents for Higher Education and the Board of Regents of the University of Oklahoma in 1979. It consists of the University of Oklahoma Congressional Archive, currently one of the largest in the nation, numbering the papers of 25 representatives and 12 senators. and academic programs sponsored in cooperation with the Department of Political Science. In addition, the Center sponsors conferences and lectures, and plans to establish a scholarly journal devoted to the study of Congress. The academic staff of the Center is composed of three political scientists, each of whom is a specialist in congressional studies. The regular issues also include non-symposium articles, literature reviews, and news relevant to the policy studies field. These symposia are funded by such sources as NSF, Department of Commerce, University of Kansas, University of Pittsburgh, and the Rockefeller Foundation. They will also result in expanded book-length versions in the PSO-Lexington series.

In addition to the PSJ journal issues and the PSO-Lexington books, the Policy Studies Organization will in 1980 be adding to its PSO-Sage series of Yearbooks in Politics and Public Policy. These will include Why Policies Succeed or Fail, under the editorship of Helen Ingram and Dean Mann; The Scope of Government: Size, Distribution, and Control in the Public Sector, edited by Robert Lineberry, John Echols, and Valerie Bunce; and Managing Fiscal Stress: Policy Responses, edited by Charles Levine and Irene Rubin. PSO will also publish a Policy Publishers and Associations Directory, which will include entries for policy-relevant journals, book publishers, scholarly associations, and interest groups. Also scheduled for publication is a Social Science Utilization Directory, which contains entries from political scientists, sociologists, economists, and psychologists in government positions, reporting how their social science backgrounds have been and could be relevant to their work.

The Policy Studies Organization is currently headed by Kenneth Dolbeare, with Charles Jones as vice president and president-elect, and Stuart Nagel as secretary-treasurer. Dues are only \$10 per year, which covers the quarterly journal, special issues, directories, and one-third discounts on the books. #### MICROCOMPUTERS Projects

CONDUIT, a University of Iowa based organization that reviews, tests, and distributes computer-based instructional materials, is launching two major new projects involving microcomputers.

The first project is funded by the National Science Foundation and will consist of two phases: an 18-month experiment followed by a dissemination period in which both the findings from the experiment and certain of the materials developed will be made widely available. The experiment will compare the instructional effectiveness of some existing computer-based instructional units with counterparts that have been converted to run on microcomputers. The microcomputer versions will be designed to take advantage of features such as graphic displays, color, audio, and various types of input devices. Subject areas for these units are mathematics, physics, chemistry, and biology. Topics in advanced undergraduate instruction will be emphasized. Selected materials developed for the experiment will be distributed through CONDUIT's existing international distribution system.

The second project, supported by the Fund for the Improvement of Postsecondary Education, immediately focuses on the need for dissemination of instructional innovation. Recognizing that the use of computers in education has fallen far short of its potential, CONDUIT will identify and disseminate 35 microcomputer-based instructional modules in a variety of disciplines, including the humanities and social sciences. A principal outcome of the project will be the impact on future development of materials by providing examples, guidelines, and standards formulated during the project.

Both projects are ambitious in scope and will require the cooperation and assistance of many individuals outside the CONDUIT central staff. In particular, authors of microcomputer-based materials are needed. CONDUIT also needs reviewers and test sites. For further information, contact CONDUIT.

CONDUIT began in the early 1970s as a National Science Foundation sponsored project to study the problems of sharing computer-based instructional materials among different institutions. Today, CONDUIT's research and development activities continue, as exemplified by these two new microcomputer projects. In addition, a review and distribution center has evolved, offering nearly 100 different sets of materials for collegiate instruction. Since 1976, when distribution activities began, CONDUIT has delivered over 4,000 instructional units to 600 colleges and universities worldwide.

#### ICPSR Quantitative Methods Program

The Inter-University Consortium for Political and Social Research Training Program in Quantitative Methods of Social Research is a comprehensive, integrated program of studies in research design, statistics, data analysis, and social methodology. In general, emphasis is focused on those topics in research methodology that

are not emphasized in the curricula of most of the social science departments at Consortiummember institutions, Furthermore, the Training Program's instructional environment differs from that of all but a few statistics departments in at least two respects:

- Methods of quantitative analysis are conveyed as part of the broader context of substantive social science research;
- (2) Virtually all instruction is coordinated with and reinforced by active, participatory, data analytic experiences.

The Summer Training Program schedule is partitioned into two four-week sessions with instruction organized in lecture, seminar, and workshop formats. The first session will be held from June 30 until July 25 and the second session will be scheduled from July 28 until August 22.

#### Program Design

The ICPSR Training Program is partitioned into three instructional tracks that are designed to satisfy the diverse research methodology needs and interests of most college and university faculty and graduate students in the social sciences.

Track I of the Training Program's curriculum consists of three courses:

Elementary Mathematics for Social Scientists (lecture)

Introduction to Computing (workshop)
Introduction to Statistics and Data Analysis
I (lecture/workshop)

These courses provide those college and university faculty and research scholars who are attempting to develop or upgrade their quantitative competencies with a basic integrated instructional program designed for that purpose. Next, Track I courses have a service function in the sense that they introduce prerequisite skills to many participants who intend to enroll in the Track II lecture/workshops in Introduction to Statistics and Data Analysis II and Introduction to Linear Models. Finally, these three courses constitute the minimal background for scholars who participate in the lecture/workshop in Quantitative Historical Analysis, the workshop in Quantitative Analysis of Crime and Criminal Justice, and the Empirical Research Issues in Aging workshop.

Track II of the Training Program consists of 13 courses:

Mathematics for Social Scientists (lecture)
Data Analysis and Public Policy (lecture)
Dynamic Analysis (lecture)

Formal Theories of Social Research (lecture)
Dynamic Models of Political Economy (lecture)

Evaluation Research Methodology (lecture/ workshop)

Experimental Studies (lecture/workshop)
Introduction to Statistics and Data Analysis
II (lecture/workshop)

Introduction to Linear Models (lecture/

workshop)

Intermediate Linear Models (lecture/work-shop)

Applied Nonparametric Analysis (lecture/workshop)

Applied Multivariate Analysis (lecture/workshop)

Multi-level Analysis (lecture/workshop)

Prerequisites for the lecture/workshops at the Track II level are an elementary college algebra course (e.g., our own Elementary Mathematics for Social Scientists) and a solid introductory course in applied statistics. Participants who enroll in these courses will divide their time between attending lectures and completing structured data analysis projects under the guidance of their instructors and the ICPSR Computer User Services staff.

Track III courses fall into three categories, with descriptive characteristics that are fairly distinct. First are those courses that belong to the curricular core of the training program and will be meaningful only to participants who have satisfied prerequisites from Track II. In some cases, the course content of these courses is on the frontier of the development of social methodology. They are:

Advanced Linear Models (lecture/workshop)
Causal Models (lecture/workshop)

Discrete Multivariate Analysis (lecture/workshop)

Exploratory Data Analysis (lecture/workshop)

Models with Unmeasured Variables (lecture/workshop)

Multivariate Dimensional Analysis (lecture/workshop)

Time Series Analysis (lecture/workshop)

Second are those courses that are substantive content-specific in the sense that the instructional focus is on the application of quantitative methods of analysis to particular substantive areas rather than on the development of the structure of the research methodologies themselves. These courses are:

Data Processing and Data Management in the Criminal Justice Field (workshop)

Empirical Research Issues in Aging (lecture/workshop)

Quantitative Analysis of Crime and Criminal Justice (lecture/workshop)

Quantitative Historical Analysis (lecture/workshop)

Research Issues in Mass Communication

Finally are those short workshops that address many of the common concerns of computing specialists and data librarians:

Database Management for Complex Data Sets (workshop)

Data Management, Library Control, and Computer Readable Information (workshop)

Introduction to Computing with SPSS (workshop)
