This is a catalog of all the books and pamphlets in Dr. Williams's Library, founded in 1729, concerned with Early Nonconformity in England from Elizabethan Puritanism to the end of the 18th century, and printed between 1566 and 1800, together with related works from Scotland, Ireland, Wales and New England. Virtually all of the historic literature of Protestant Dissent in Britain is covered, although the library's numerous works by European Reformers and Huguenot and Dutch theologians are not included. The bibliography is in three parts, which may be purchased separately: authors, specific alphabetical subjects, and chronology. There are various useful cross-references and identifications of many authors, editors, writers of prefaces, etc., hitherto anonymous.
