LITTLE-KNOWN LATIN AMERICAN MANUSCRIPTS AT THE UNIVERSITY OF TEXAS

The Nettie Lee Benson Latin American Collection at the University of Texas is internationally known as a major repository of primary source material on colonial and nineteenth-century Mexico. Specialists may also be aware of its collections of historical documents on the Río de la Plata and Central America. The best-known manuscripts were acquired before 1940 and have been described in widely distributed published guides.¹

This collection of documents has grown steadily since 1940, having doubled in size in the last quarter-century. Few researchers are aware of this expansion, however, partially due to the lack of printed guides. In a few years, it may be possible to compile a more complete indexed guide to these materials. The purpose of the present list is to describe a broad selection of the more recent acquisitions and to inform interested researchers of their availability. Some of the more recently received and newly opened collections are described here publicly for the first time.

The pre-1940 collections totaled about half a million pages of manuscripts, maps, photographs, and associated materials ranging from a 1524 letter by Hernán Cortés to revolutionary broadsides of the Victoriano Huerta period. Most of this material arrived in five collections: the Joaquín García Icazbalceta Collection (50,000 pages on early colonial Mex-

ico), the Genaro García Collection (300,000 pages on colonial and nineteenth-century Mexico), the W. B. Stephens Collection (20,000 pages on northern Mexico and the southwestern United States), the Justin Smith Collection (10,000 pages on the U.S. war with Mexico), and the Manuel Gondra Collection (20,000 pages on colonial and nineteenth-century Paraguay). The first four collections document early Mexican history in almost every aspect from exploration, Indians, missions, land holdings, mining, commerce, and education to government and church administration, foreign relations, and even a small section of plays and poetry. The material varies widely in nature and source, but perhaps the richest files for research are the sixteenth-century "Relaciones geográficas" for central and southern Mexico and Guatemala and the correspondence of nineteenth-century political leaders including Vicente Guerrero, José María Luis Mora, José Servando Teresa de Mier, Antonio López de Santa Anna, Ignacio Comonfort, Lucas Alamán, Vicente and Mariano Riva Palacio, and Valentín Gómez Farías. The Manuel Gondra Manuscript Collection (mostly typed copies of archival documents but with some originals) includes detailed reports of economic, political, and social conditions, military campaigns, Indians, Spanish settlements, missions, governmental and ecclesiastical administration, commerce, and international relations in the Río de la Plata region.

In the "newer" manuscripts described in this research note, colonial papers are also numerous, particularly church and hacienda records, but nineteenth- and twentieth-century materials predominate. While papers on international relations, politics, and the military abound, business and literary materials are growing in significance. Geographically, Mexico continues to be the primary focus of the Benson Collection, but most South and Central American countries are also represented in documentary sources.

These records include several noteworthy individual collections: correspondence of Lord Thomas Cochrane, Antonio Guzmán Blanco, Gabriela Mistral, and Pedro Henríquez Ureña; archives of the St. John d'El Rey Mining Company of Brazil and the Probert Collection on the Real del Monte Mines in Mexico; transcripts of the 1985 Argentine investigations of the *desaparecidos*; and drafts of major works by Julio Cortázar and José Vasconcelos.

Many of the collections fall into thematic groups that offer substantial research potential. Among the stronger groups are materials related to politics and business during the Mexican Revolution, including the William F. Buckley Papers, records of the Ferrocarril Noroeste de México, papers of Lázaro de la Garza (Pancho Villa), and numerous records of companies and private investors from the United States. Another important and expanding group comprises the files of businesses, haciendas, *ingenios*, *gremios*, and mines from the colonial period through the early

twentieth century. Similarly, the literary files are growing into a significant collection.

The materials to be described here are, with few exceptions, original documents, whether manuscript or typescript. Excluded are the library's extensive collections of photographs, broadsides, archival microfilms, and Mexican American archival collections, each of which has or will have a separate guide.²

The list of papers is organized in two series: history and social sciences first, followed by a second section on literature, humanities, and the arts. Within each series, the arrangement is alphabetical, first by country and then by author or title of each collection. Papers relating to several countries are alphabetized in both series under the heading "Latin America."

Hand-corrected draft of memoirs of German publisher associated with Editorial Cosmopólita in Buenos Aires. Essays on German-Jewish life, culture, publishing, and politics in Argentina, 1939–1946.

Marco del Pont, Ventura Miguel

Papers, 1799–1879. 191 documents. Primarily commercial activities of an important Buenos Aires merchant, 1806–1810.

Partido Demócrata Progresista, Movimiento de Afirmación Demócrata Progresista

Papers, 1930–1964. 1 inch. Typed correspondence from party officials, printed announcements, propaganda sheets, posters, and newsclippings.

Bolivia

Cochabamba, Bolivia. Consejo Municipal and Consejo Departamental

"Libro copiador de oficios del Consejo de Gobierno y demás autoridades políticas y civiles desde octubre 15 de 1875 hasta octubre 30 de 1881." 411 leaves. Table of contents. Letters to national officials regarding taxes, road building, education, and similar matters.

Cochabamba, Bolivia. Prefectura del Departamento

"Libro de proviciones [sic], tomo 3." 231 leaves. Table of contents. Official resolutions, circulars, orders, appointments, and decrees, received or sent by the prefecture, 1845–1851.

Compagnie Aramayo de Mines en Bolivie

Annual reports of directors and speeches of chairmen, 1931–1959. 60 printed documents.

O'Brien, W. D.

"Report on the Physical and Technical Features, Funds Required to Equip, and Earning Power of the Placer Gold Deposits Situated in the Tipuani River Basin, Republic of Bolivia, South America." Dec., 1930. 93 leaves. Includes 25 original photographs, 5 maps, and 7 earlier reports.

Oruro, Tesorería Real

"Libro manual de la Sta. Cruzada del cargo de los oficiales reales de la villa de Oruro. . . ." 68 leaves (Misc. ms. 7). Amounts received from priests for sale of religious bulls, 1698–1722.

Superior Oil Company

"Testimonio de la escritura de contrato de servicios para exploración y explotación de yacimientos petrolíferos otorgada por Yacimientos Petrolíferos Fiscales Bolivianos a favor de the Superior Oil Company (California) año 1946, no. 81." Also, carbon copy of decree approving contract, signed by President Tomás Monge Gutiérrez, 1946. 34 leaves.

Brazil

Amazon Wireless Telegraph and Telephone Company

"Petition to U.S. Secretary of State for aid in protecting Company's rights and concessions in Brazil." 99 pages. Carbon copy, dated 7 Dec. 1911, from law firm Ivins, Mason, Wolff and Hoguet. Details actions, services, and ownership of this company in Amazonas and Pará as well as its French competition.

Banco Real, S.A. (São Paulo)

Documents. 1 inch. Notarized copies of documents related to the bank's founding as the Banco de Lavoura de Minas Gerais, its history (1925–1981), balances (1970–1981), structure, and statutes.

Dulles, John W. F.

Brazil Collection. 44 inches. 430 interviews with background photographs, clippings, and correspondence regarding politics and the Communist party in Brazil, 1959–1979, covering the Aragarças Rebellion, the overthrow of Goulart, the selection of Castelo Branco, anticommunists, the Liga Democrática Radical, and labor.

St. John d'El Rey Mining Company Archive

360 feet. Typed inventory of 4 pages. Records of British mining company and its town in Minas Gerais, 1830–1960. Annual reports, board minutes, share registers, account books, administrative correspondence,

mining reports, maps, plans, contracts, deeds, 1900 photographs, and employee records (wills, baptisms, marriages, deaths).

Whately, Mario

Papers. 1 inch. Newspaper clippings on the career of this São Paulo federal deputy (1927–1944), 1934 election book of the Partido Republicano Paulista, 5 photographs, 2 letters.

Chile

Cochrane, Thomas

Correspondence. 143 pages. Copybook of his letters written as Vice Admiral of the Chilean Navy to Bernardo O'Higgins (1819–1822). Reports on sea war, disagreements with José de San Martín in Lima, correspondence between San Martín and Bernardo Monteagudo, and the George Guise affair.

Hanna, John

Journal and letter book. 38 pages, 24 leaves, 120 pages. They cover his 1817 sea voyage from India to England, 1819 voyage from Liverpool to Buenos Aires and Valparaíso, stint as ship surgeon in the Chilean Navy during the War of Independence, blockade of Callao with Thomas Cochrane; service with José de San Martín's army in Peru and Bolivia, and later civilian work in Peru to 1827.

Colombia

Pray, Benjamin S.

Correspondence. 167 documents. Colombian gold-mining explorations and operations (in Quibdo and Choco) and Brazilian diamond mining (Diamantina), 1884–1923. Reports from site managers and letters to investors, directors, and equipment suppliers.

Slavery in Colombia Documents

450 leaves. Edicts issued from 1821 to 1852 regarding manumission of slaves, half from the Cantón de La Plata.

Stines, Norman C.

"Placer Gold Deposits of Southwestern Colombia, South America, and Proposed Program for Securing and Proving One Area Suitable for a Dredging Unit." Typescript dated San Francisco, 12 June 1931. 135 leaves, 14 photographs, 4 maps. Describes mining claims, prices, operations, productivity, local mining history, and geology along the Tapaje, Maqui, and Sipi rivers.

El Salvador

"In the Name of the People"

Consists of 19 videocassettes, 14 audiocassettes, and English and Spanish transcripts. Recorded interviews made by Alex Drehsler around 1981 with residents and rebels in guerrilla-held sector. From these interviews, the documentary film of the same title was produced. Topics discussed include land, women's roles, recruitment, guerrilla organization, and daily activities in this area.

Guatemala

Adams, Richard N.

Guatemala Project Papers. 55 feet. Field notes and collected documentation of anthropology research projects of graduate students in the 1960s. Political, social, and economic information.

Haiti

Corneau, John Baptist Toussant

"Narrative of the Life of John Baptist Toussant Corneau and of His Family" 1 volume of 244 pages and 1 letter (Misc. mss. 86, 88). Memoirs of his trip from France to a Santo Domingo plantation in 1799 discussing agriculture, labor, and black revolts there as well as his escape to Cuba and the United States in 1804.

Little, Ed, and John Warren Dubois Gould

Documents on Haiti, 1916. 90 pages (Misc. ms. 31). Log of trip to Haiti by Little and "General Report on Haiti" by Gould as representative of the Chartered Company of Haiti.

Honduras

Cuyamel Fruit Company

Expedientes. 1 volume of 184 leaves (Misc. ms. 85). Papers relating to transfer of land concessions to company of Samuel Zemurray and Ashbel Hubbard. Measurement and rental of land in Cortez province, port rights, report on railroad construction, proposed dock in Omoa, map and official gazette clippings, 1911–1913.

Latin America

Alliance of Pan American Round Tables

Archive. 18 feet. Correspondence, international meeting reports, scrapbooks, publications, minutes of board meetings, committee reports, and photographs of this organization of women interested in Latin America, from 1940 to the present.

Niemeyer, E. Victor, Jr.

Papers. 14 feet. Related to his work as director of U.S. binational cultural centers in the Philippines, Guatemala, Peru, Honduras, Monterrey (Mexico), Santiago (Chile), and as U.S. embassy or consular officer in Trinidad, Mexico City, and Monterrey, 1953–1979. Correspondence, announcements, invitations, programs, pamphlets, clippings, notes, photographs, writings, and memoranda, including material from schools, churches, and social and service clubs in those locations (especially the American School Foundation of Monterrey and Partners of the Americas).

Varner, John Grier, and Jeannette J. Varner

Collection. 18 feet. Correspondence, research notes, photographs, maps, drafts, and publications, mostly related to the Varners' published works: The Florida of the Inca; El Inca: The Life and Times of Garcilaso de la Vega; and Dogs of the Conquest.

Mexico

Arrigunaga Coello, María de

Arrigunaga Collection of Yucatecan Broadsides and Manuscripts. 8 inches. 102 broadsides, pamphlets, and manuscripts. Typed list available. Covers Yucatecan and other Mexican politics, military, and church affairs, 1762–1878.

Banco Mercantil de Yucatán, Mérida

Libros borradores. 25 inches. 18 letter books, 1890–1908, of account transfers, payments, receipt records, and correspondence.

Barradas, Isidro

Campaña de Barradas, 1829. 13 leaves. Unsigned report of expedition to reconquer Mexico with 4,000 troops, purportedly written by a participant.

Buckley, William F.

Papers, 1913–1922. 25 feet. Clippings and correspondence related to Mexican politics, leaders, revolution, internal conditions, relations with the United States, economic and business conditions, Niagara Conference of 1914, U.S. occupation of Veracruz, and oil companies' relations with the Mexican government.

Canalizo, Valentín

Correspondence addressed to General or President Canalizo, 1835–1844. 39 leaves. Includes 19 letters from Antonio López de Santa Anna, A. Bustamente, Nicolás Bravo, and others involved in government and military affairs. Located in the William J. Kelleher Collection, folder 19.

Cholula

López Valdez, Pablo. "Proyecto Cholula: reporte preliminar de la

cerámica arqueológica, 1967." 14, 2, 50, 68 leaves. Report on pottery recovered in Cholula, site plans, 2 volumes of colored drawings and typed descriptions of pottery.

Clarke, Borden

Borden Clarke Collection. 78 documents. Covers the War of Independence, 1810–1814, including correspondence to and from José María Morelos; also colonial Catholic Church fiscal affairs. Has alphabetical and chronological index files.

Compañía de la Sauteña (Tamaulipas)

Documents, 1908. 20 leaves (Misc. ms. 28). Proposal to bring European Catholic colonists to Tamaulipas by Gustave Husson and Maurice Satre of Matamoros.

Conde de Revilla-Gigedo, Virrey

"Instrucción reservada que dexó el Sor Virrey Conde de Revilla-Gigedo a su Succesor el Sor Marqués de Branchiforte." 1794. 1 bound manuscript volume with table of contents.

Convento de la Santísima Trinidad (Puebla)

"Minuta de los reales que tengo recaudados de las rentas del Convento . . ." 76 documents. Weekly financial reports of the convent, 29 Aug. 1752–25 Oct. 1763, incomplete.

Convento de San Gerónimo, Mexico, Monasterio de Sancta Paula de la Orden de San Gerónimo

"Libro de Profesiones y Elecciones de Prioras y Vicarías." 1 volume of 214 leaves with index (in Dorothy Schons Papers). Matriculation book from founding in 1586 to 1713. Includes signed vows of Sor Juana Inés de la Cruz.

Diego, Obispo de Guadalajara

"Memorial," 1767. 21 leaves (Misc. ms. 79). Denial of permission for a Mexico City Franciscan to raise money in Guadalajara. Bishop's ruling, response from prelates, explanation to the audiencia.

Dulles, John W. F.

Papers relate to research for *Yesterday in Mexico*. 60 inches. Card index. Politics and industry, 1950–1959: correspondence, photographs, telegraph messages, newsclippings, interview notes (from Plutarco Calles, Emilio Portes Gil, Alberto Pani, Ezequiel Padilla, Laurens, Marte Gómez, Pascual Ortiz Rubio, Abelardo Rodríguez, Adolfo de la Huerta, Lázaro Cárdenas, and others).

Dulles, John W. F.

Report to the Compañía Metalúrgica Peñoles on 11 mines and smelters in northern Mexico. 127 leaves. Descriptions, operations, assay reports, and production, 1946–1948.

Ferrocarril Noroeste de México

Archive. 2 feet, 2645 documents. Part of the business archives of the Mexican Northwestern Railway Company, 1910–1919, with correspondence and records related to economic effects of activities of the government and rebel forces during the revolution.

France, Ministre de la Guerre

Expédition du Mexique, 1862–1866. 3 volumes (Misc. ms. 36). Includes 94 letters, 118 reports, 7 orders, 25 pages of accounts, and 108 service records of French forces under Latrille, Comte de Lorencez.

Franciscans in Mexico

"Libro de profesiones de este Convento de Sor. Sn. José de la Villa de Tacubaya." 108 leaves in 1 volume (Misc. ms. 75). Book 5 of the register covers October 1786 to April 1849, listing age, birthplace, and parents of new friars.

Franciscans in Mexico

Provincia del Santo Evangelio. "Haec est tabula congregationis capitularis intermediae. . . ." 11 leaves (Misc. ms. 15). Cover letter from Fray Antonio Crespo to Viceroy Iturrigaray with list of officers elected on 22 October 1803.

Garcés de Salazar y Abarca, Tomás

Documents related to the will of the deceased Lic. Garcés, abogado de la Real Audiencia. 562 pages (Misc. ms. 87). Will, inventories, and statements of this family in Puebla, 1799–1826.

Garza, Lázaro de la, Francisco (Pancho) Villa

Archive. 3 feet (some 3600 documents). Typescript guide. Papers of Villa's financial agent in Torreón, Coahuila, 1913–1928, with correspondence, bills, purchasing arrangements, currency production, lawsuits, clippings, photographs, and personal papers.

Gremio de Plateros, Batiojas y Tiradores de Oro de Mexico

Book of acts, meetings, and elections. 2 volumes (Misc. ms. 1). Minutes of meetings, financial accounts, activities of *hermandades*, administration of property, elections, 1728–1848.

Hacienda de San Francisco Algibe, Tepeaca

Official possession and sale of hacienda to Juan Ferrer Ugarte. 23 leaves (Misc. ms. 14). Description, inventory, evaluation, and formal transfer of property, 1793.

Hacienda de San Mateo de Tecoloapán

Account books, 1893–1895. 4 volumes. Production and sale of pulque, milk, and maize.

Hacienda del Nacimiento, Coahuila

Title papers. 1 volume with table of contents. These 27 documents, 1762–1908, detail boundaries and ownership transfers among families of Sánchez Navarro, David McKellar, George Nelson, and Tabitha Wellar.

Iglesia Católica Apostólica Mexicana

Collection of 13 items (Misc. ms. 33). Broadsides, letters, newspapers, and drafts of 2 Herbert Gambrell articles related to schismatic Catholic Church in Mexico, 1925–26.

Ingenio or Hacienda de San Miguel Almolonga, Xalapa

Records, 1572–1944. 639 leaves in 1 volume. Land records for 1572–1911; other records, 1907–1944.

Janos, Chihuahua (Presidio)

Archives. 8 feet. Typed two-volume calendar covers 1706 to 1828; 1829–1858 not indexed. Baptism and marriage records, presidio accounts, administrative correspondence, copies of circulars and decrees, reports, and inventories.

Ker, Graham M.

Reports. 11 leaves and 15 pages (Misc. ms. 58 c, g, k-s). Firsthand accounts of the revolt led by Félix Díaz against Francisco Madero in Mexico City, Feb. 1913, and Alberto Sámano raid of Tapachula in July 1920.

Kile, Sherman C. (Capt., U.S. Army Intelligence)

Papers, 1917–1920. 8 inches. Reports, publications, and other papers on German sympathizers, U.S. friends of Mexico, and Mexican revolutionary activities along the U.S.-Mexican border, apparently gathered for the Southern Department of U.S. Army Intelligence.

Latorre, Felipe, and Dolores

Collection on the Kickapoo Indians. 9 feet. Ethnological field notes, correspondence, publications, photographs, and microfilm, mostly on the Kickapoo in northern Mexico, 1929–1940 and 1960–1973.

Maximilian, Emperor of Mexico, and Mariano Degollado

Correspondence and other papers. 87 items (Misc. ms. 61). Degollado was the Mexican envoy to the Vatican. Includes 28 letters from Maximilian to Degollado regarding the political and military situation in Mexico and foreign affairs, plus envoy's invitations, appointments, notes, clippings, and engravings.

Mecham, John Lloyd

Collection on New Spain and Northern Frontier. 2 feet. Index file. Transcripts from the Archivo General de las Indias, pamphlets, and original manuscripts related to exploration and settlement of northern Mexico, 1581–1612.

Mexican Political Party Propaganda, 1910-1920

Collection of 263 items in 1 volume (Misc. ms. 22). Subjects include women, Yankee invasion of Veracruz, Germans in Mexico, Venustiano Carranza, Emiliano Zapata, Porfirio Díaz, Pancho Villa, Alvaro Obregón, labor, the military, election campaign announcements, *corridos*, and student protests. Mostly broadsides, song sheets, and newspapers.

Mexico, Cathedral of

Directory of church officials, 1562. 1 leaf, 18 by 72 inches. Names, titles, wages, and service records of 57 priests.

Muse Purchase

1 foot containing 669 documents. Alphabetical and chronological card index. Manuscript letters and documents and printed broadsides related to Mexican internal affairs, 1831–1837; political and military situation in Texas, 1835–1837, 1843; Veracruz revolt in 1832; Tabasco revolt in 1844; Pastry War; and California, 1836–37.

O'Gorman, Edmundo

Collection. 5 feet, 287 ms. documents. Typescript subject and name indices; chronological card-file index. Church, army, land, and family records from the sixteenth through the twentieth centuries. Three-fourths relate to the Valle de México in the seventeenth and eighteenth centuries: property, wills, contracts, church, mining (Pachuca), Indians and blacks, and the Condado del Valle de Orizaba. Also important are nineteenth-century reports on Mariano Ariste and the organization of the Mexican Army.

Parras, Coahuila, Colegio de San Ignacio de Loyola

Archivo histórico del Colegio de San Ignacio de Loyola en Parras de la Fuente, Coahuila, 1620–1910. Photocopies. 6.5 feet. Typed list of *expedientes* in chronological order within each *fondo: eclesiástico, civil,* and *eclesiástico-civil*. Church accounts, registers, and edicts; civil and criminal cases; and government acts and decrees.

Pastor, Plácido
