## SHEA Membership Continues to Grow

As the premier organization of advanced-degree epidemiologists, SHEA continues toward the strategic membership goals that were outlined at the January 1996 strategic planning meeting. SHEA membership exceeded 1,200 for the first time in August, prior to the recruitment opportunity represented by the annual SHEA presence at the ICAAC/IDSA meeting in September 1996. The highest recorded degree was an MD or DO

for more than 1,100 members; a PhD for more than 50; and a DVM for 1. SHEA now has 13 masters-degree members, each nominated by a SHEA member because of their particular epidemiologic accomplishments (this class of membership is limited by the bylaws to 5% of total membership). Many of our members have dual degrees, particularly MD or RN, plus PhD or MPH.
